Less regulation / inspection / data

- CAA abolished with immediate affect. Children's Service continue to be assessed by Ofsted. OfSTED is under a statutory duty to produce an annual assessment of the quality of children's services for each local authority, and will continue to do so until the duty is changed. Budget / In year reductions

- £311m cut to area based grant for Children's Service
- The National College for Leadership of Schools and Children's Services budget is to be cut back by £16m
- £15m is to be slashed from the Children's Workforce Development Council.
- The Young People's Learning Agency (YPLA), budget will be cut by £20m, £13m of which come from getting rid of a development fund, the remainder of which is a surplus of cash that is yet to be allocated to schools and colleges.
- S31 The Children and Young People (Revenue) Grant for 2010-11 is to be an unring fenced grant. This grant integrates the Think Family Grant, Youth Opportunity Fund, Challenge and Support Fund and Youth Crime Action Plan. - There will be a real terms increase in school expenditure of 0.1 per cent a year, with an increase in the 5-16 schools grant of £3.6 billion (includes £2.5 billion pupil premium for disadvantaged children)

Phase out ring fencing around grants

- To assist LA helps make the required efficiency savings, the Government intend to remove the ring fencing around £1.7 billion in grants to LAs during 2010/11.

BSF

- DfE press notice 5/7/10 BSF program bought to an end The key elements of today's announcement are:
 - That the Government is launching a comprehensive Review of all capital investment in schools, early years, colleges and sixth forms.
 - The review will guide future spending decisions over the next Spending Review period (2011-12 to 2014-15). It will look at how best to meet parental demand; make current design and procurement cost-effective and efficient; and overhaul how capital is allocated and targeted.
 - o That the department is reducing its End Year Flexibility (EYF) requirements by £1bn to help ensure no additional borrowing this year.
 - The Secretary of State is also announcing today that he will be ending the £972,000 annual funding for the Commission for Architecture and the Built Environment (CABE) design advice service associated with the BSF programme.

Academies bill / Free Schools

- Academies Bill passed and became law. http://www.cypnow.co.uk/ 27/7/10
- Bill enables primary, secondary and special schools to change to become academies (those rated as outstanding can be fast tracked through the system)
- In summary academies are:
 - Funded by central government rather than through the local council
 - Free to set their own curriculum as long as it is "broad and balanced"
 - o Responsible for their own admissions, but bound by the Admissions Code
 - Able to set terms and conditions for teachers and other staff
 - Receiving money previously spent on their behalf by councils for services such as those for children with special needs or excluded from school
- Particular provisions included in the Academies Act:- 2 parent governors on governing body; must promote community cohesion; a designate teacher for LAC; Sec of State has final say on SEN funding http://www.education.gov.uk/academies4/8/10
- The bill also enables 'Free Schools' to be set up. Free schools can be set up by any suitable proposer, where there is evidence of parental demand such as a petition or declaration from interested parents. This could include one or more of the following groups:
 - o charities
 - o academy sponsors
 - o universities

- o independent schools
- community and faith groups
- o teachers
- o parents
- o businesses.

The Secretary of State will consider each proposal on its merits, and take into account all matters relevant to that proposal.

 - o Competitive sports to be encouraged

Education and Children's Bill

- The main elements of the bill are:
 - To provide schools with the freedoms to deliver an excellent education in the way they see fit.
 - To reform Ofsted and other accountability frameworks to ensure that head teachers are held properly accountable for the core educational goals of attainment and closing the gap between rich and poor.
 - To introduce a slimmer curriculum giving more space for teachers to decide how to teach.
 - o To introduce a reading test for 6 year olds to make sure that young children are learning and to identify problems early.
 - To give teachers and head teachers the powers to improve behaviour and tackle bullying.
 - To raise standards across the education sector through the creation of more Academies and giving more freedom to head teachers and teachers. Also ensure that money follows pupils, introducing a 'pupil premium' so that more money follows the poorest pupils.

Pupil premium

- From September 2011 schools will be given a cash (£2400 approx) incentive for every underprivileged child they teach, as part of a shake-up of schools funding. The payments, which will come from outside the budget for schools, are intended to stop the middle classes dominating the best schools and correct the "significant underachievement" of disadvantaged pupils compared with their peers. http://www.education.gov.uk

In the context of raising the participation age, there will be unit cost reductions in the 16 to 19 participation budget and the support currently provided by Education Maintenance Allowances will be focused on the most disadvantaged children, saving around £0.5 billion

Further moves to reduce bureaucracy and red tape in 16 to 19 education have been announced by the Government.

- o Freeing up local authorities to focus on their strategic role in 16-19 education
- Scrapping the need for local authorities to set up 'sub-regional groups' and 'regional planning groups'
- From August, paying further education colleges, sixth form colleges and other training providers direct from the Young People's Learning Agency
- The National commissioning framework will not be replaced until the publication of the Education White Paper (due 1 November)

 This will bring state schools in line with independent schools.
 - The development of the new Diplomas in science, humanities and languages, due to be introduced from September 2011, will cease immediately diplomas becoming vocational rather than general

Contact Point

When ContactPoint is switched off, local authorities statutory responsibilities will no longer apply. Youth Offending

- MOJ blunder leaves councils in charge of offender education. A delay order published on 29/7/10 delaying councils becoming responsible for young offenders education until April 2011 was never put into place leaving councils forced to take over in September 2010 as originally planned by the 2009 Apprenticeships, Skills, Children and Learning Act http://www.cypnow.co.uk/
- Although responsibility for funding and contracts for young offender education was to be transferred from the YPLA to councils immediately the MoJ is apparently now considering "whether it makes sense for the duties to transfer from the YPLA to local authorities". http://www.cypnow.co.uk/

- Lifestyle survey stopped. This was previously used to collect data for the following measures which are included in the Community Strategy
 - % of YP in each group who feel that views and opinions are listened to in school
 - o % of young people in secondary schools who had ever tried drugs
 - o % of young people certain they know someone who uses drugs

Children's Trust

- Fairness premium worth £7bn to be introduced for all disadvantaged two year olds entitling them to 15 free hours of early education and care 15/10/10 http://www.education.gov.uk/
- 4,200 Sure Start Health visitors to be recruited. The level of funding will be announced in due course. Health visitors will also be trained in the SAFER referral technique (<u>Source</u>)
- Sure Start will be refocused on its original purpose of improving the life chances of disadvantaged children and targeting early intervention on families who need the most support
- Reforms to Sure Start children's centres will encourage more community providers to enter the market, including through payment by results
- The introduction of an early years single funding formula will also "make the market more fair and equitable."

DfE & the Spending Review

- Statement about the spending review from the DfE
 - o Reduction in resource spending of 3% by 2014-15
 - Capital spending will be reduced by 60% in real terms by end of SR period from baseline £7.6bn falling each year to £3.4bn by 2014-15
 - Schools- funding increased by £3.6 billion by end of 2014-15 = 0.1% increase annually.
 - Pupil premium to support educational development of disadvantaged pupils and provide incentives to good schools to take pupils from poorer backgrounds
 - o 33% reduction in real terms by 2014-15 from Departments administrative budget
 - o Applying measures suggested through the Spending Challenge
 - Next Steps include a Schools' White Paper and an SEN and Disability Green paper, further announcements about allocating voluntary sector grants, and confirmation of LA allocations for schools and early years provision. We will announce further programmes and further bureaucracy we intend to end in the next three months
 - Revenue expenditure by DfE will rise each year, from a baseline of £50.8bn to £51.2;£52.1; £52.9; and £53.9 in 2014-15. This represents a percentage change of 3.4% in real terms http://www.education.gov.uk/
- Later this year, each Government department will publish a business plan setting out the details of its reform plans, including its:
 - o vision and priorities to 2014-15
 - structural reform plan, including actions and deadlines for implementing reforms over the next two years; and

Big society

Big Society is the Conservatives vision for handing power back to communities. It highlights three main areas:

- 1. Strengthen and support social enterprises to help deliver public service reform
 - Create an independent Big Society Bank, funded from unclaimed bank assets, which will leverage private sector investment to provide hundreds of millions of pounds of new finance for neighbourhood groups, charities, social enterprises and other non-governmental bodies.
 - One of the purposes of the Big Society Bank will be to provide funds to intermediary bodies with a track record of supporting and growing social enterprises.
- 2. Stimulate the creation and development of neighbourhood groups in every area
 - Establish National Centres for Community Organising and fund the training of 5,000 independent community organisers over the lifetime of the next Parliament. Organisers will have the skills needed to raise funds to pay for their own salaries,

- help communities to establish and operate neighbourhood groups, and help neighbourhood groups to tackle difficult social challenges.
- Providing neighbourhood grants for the UK's poorest areas. (micro-funding will go to charities and social enterprises to work with new and existing neighbourhood groups in the most deprived and broken communities).
- 3. Encourage mass engagement in neighbourhood groups and social projects
 - Transforming the civil service into a 'civic service' by making regular community service a key element in staff appraisals. This will help to bring about a culture change throughout the civil service.
 - Launching an annual national 'Big Society Day' to celebrate the work of neighbourhood groups and encourage more people to take part in social action projects.
 - Big Society / National Citizen Service Pilots. Aimed at school leavers aged 16, pilots 2011 June to Sept. Activities designed introduce young people to the concept of civic responsibility.
