REPORT OF THE DIRECTOR OF THE URBAN ENVIRONMENT

PROPOSALS FOR DISABLED PARKING PLACES PROGRAMME G

1.0 <u>PURPOSE</u>

1.1 The purpose of this report is to consult and invite comments from Committee regarding requests to be included in Programme G of the on-street Disabled Parking Places scheme.

2.0 BACKGROUND

- 2.1 Traffic Regulation Orders for the establishment of parking places near the homes of registered disabled persons are introduced twice every year.
- 2.2 These reserved spaces are provided for named individuals who do not have offstreet parking facilities and whose level of disablement qualifies them for registration as Blue Badge holders. One permit is issued for each parking place, which is marked out on the carriageway as a white 'box'.
- 2.3 In the six month period up to April 2004, 6 applications in your Committee's area were received.
- 2.4 Appendix A displays the sites in your Committee's area where no objections have been received and are recommended for introduction.
- 2.5 Appendix B displays the objections which have been made to an application in your Committee's area, where it is recommended that the objections should be upheld and the application not succeed..
- 2.6 Appendix C displays the objections which have been made to an application in your Committee's area, where it is recommended that the objections should be overruled.
- 2.7 <u>Consultation</u>
- 2.7.1 Letters regarding the applications were sent to the Police on 24/8/04.
- 2.7.2 The proposals were published in the "Express and Star" newspaper on 27/10/04 and also on-street between 27th October and 22nd November 2004.
- 2.7.3 Members were consulted by letter on 24/8/04 and no objections were received.
 2.8 <u>Sustainable Transport</u>

The introduction of on-street Disabled Parking Places assists registered disabled persons to park near their homes and to live in the community.

3.0 PROPOSAL

- 3.1 It is proposed that the Cabinet Member for Transportation be advised that the schemes detailed in Appendix A be recommended for introduction as advertised.
- 3.2 It is also proposed that the Committee advises the Cabinet Member for Transportation that the objections to the sites shown in Appendix B should be upheld and the sites should not succeed.
- 3.3 It is also proposed that the Committee advises the Cabinet Member for Transportation that the objection to the sites shown in Appendix C be overruled and the site recommended for introduction as advertised.

4.0 <u>FINANCE</u>

4.1 Implementation of on-street Disabled Parking Places Orders is estimated at £200 each and, subject to funding being made available, would be funded from the Highways Capital Budget.

5.0 <u>LAW</u>

5.1 On-street Parking Places reserved for permit holders are made under Section 45(2) of the Road Traffic Regulations act 1984.

6.0 EQUAL OPPORTUNITIES

6.1 The proposals contained within this report are intended to benefit registered disabled persons. They comply with the Council's Equal Opportunities Policy.

7.0 <u>RECOMMENDATION</u>

7.1 That Members support the proposal contained in Paragraph 3.0 of this report.
