**STOURBRIDGE AREA COMMITTEE – 28<sup>TH</sup> JUNE 2010**

**REPORT OF THE DIRECTOR OF THE URBAN ENVIRONMENT**

**TO SEEK SUPPORT FOR THE BOROUGH WIDE AIR QUALITY ACTION PLAN FOR DUDLEY**

**Purpose of Report**

- 1 This report is to provide members with details of the Air Quality Action Plan proposed for Dudley Metropolitan Borough Council. It addresses the following issues:
  - Areas identified as having poor air quality
  - Air Quality Management Area Declaration leading to the air quality action plan.
  - Air Quality Action Plan progress
  - Actions designed to improve air quality within Dudley Metropolitan Borough

**Background**

- 2 Dudley Metropolitan Borough Council has a statutory duty under the provisions of the Environment Act 1995 to review and assess air quality in its area. Since the publication of the first edition of the National Air Quality Strategy (NAQS) in 1997, Dudley MBC has either monitored or modelled concentrations of all NAQS pollutants (except for hydrocarbons where there is no requirement to do so) across the Borough. This work indicated that only nitrogen dioxide and fine particulates need to be monitored to comply with its obligations under Local Air Quality Management (LAQM) requirements.
- 3 The latest air quality data collected indicates that air quality in Dudley continues to be generally acceptable with concentrations of fine particulates meeting current NAQS objectives. However, breaches of the annual mean nitrogen dioxide objective have been confirmed at several roadside locations across the borough.
- 4 Dudley MBC is legally required to declare one or more Air Quality Management Areas (AQMAs) for those parts of the Borough in which the air quality objective is likely to be exceeded. Declaration of The whole Borough AQMA was completed in December 2007, amalgamating the former AQMAs of Brierley Hill and Sedgley.
- 5 In response to the declaration of the Borough as an Air Quality Management Area an Air Quality Action Plan has been prepared which identifies the areas

within the Borough where known air quality objectives are being or likely to be exceeded and proposes measures to address the exceedences. A copy of the draft plan is available in the Members room.

6 Exceedences of the annual mean objective for nitrogen dioxide were confirmed at the following locations in the area covered by this Area Committee:

- Lye- Pedmore Road, Dudley Road
- Amblecote- High Street

The following locations in other areas of Dudley were also identified during the survey:

- Dudley- New Street, Buffery Road, Birmingham Road in close proximity to Burnt Tree Island and the Town Gate Retail Park
- Netherton- Halesowen Road
- Quarry Bank- High Street
- Brierley Hill- High Street (prior to construction of new parallel route)
- Pensnett- High Street
- Wordsley- High Street
- Cradley- Windmill Hill
- Halesowen- Stourbridge Road, Hagley Road
- Sedgley- High Street, Dudley Street
- Lower Gornal- Himley Road

7. The major source of air pollution in these areas has been identified as due to emissions from the exhausts of road vehicles. Work undertaken as a part of the preparation for the AQAP has demonstrated that there is a larger contribution from heavy goods vehicles and passenger transport vehicles operating in the areas with poor air quality than other areas. Further research & collaboration with our partners such as CENTRO on this issue is required to determine how best to combat the problem.

8. The Dudley MBC AQAP was submitted to Department for the Environment, Food and Rural Affairs (DEFRA) during February 2010 for further comment and received positive feedback. The following comments were noted:

*It is clear that whilst creating the consultation AQAP DMBC have considered the statutory guidance extensively. The draft document should be commended and with minor alterations the DMBC AQAP could be cited as an example of best practice.*

*Overall this is a comprehensive report and it is believed that the AQAP has every chance of being successful. The Council should be commended for their efforts in producing this report and are encouraged to provide similar detail in future progress reports and action plans.*

9. Full consultation will now be undertaken with residents of Dudley Borough and other interested bodies, starting with reports to the five Area Committees. In

addition It is our intention to undertake consultation via the Dudley MBC web site, specific contact with residents living within all of the areas known to be exceeding the air quality objectives (as listed above in point 6 of this report) and work with local centre regeneration consultation initiatives and events to publicise the AQAP at centres within the Borough with the assistance of the Councils marketing team.

10. The crux of the AQAP is to provide actions which can be undertaken to help prevent further increases in air pollution and where practicable reduce concentrations of Nitrogen Dioxide to below National Objectives. The actions proposed in the AQAP are listed under the following headings:
  - *Encouraging Changes in Travel Behaviour – work with key stakeholders to encourage the use of public transport and the use of less polluting ways to travel, eg, cycling, car sharing, walking.*
  - Information & Awareness Raising – ie improved website and information for schools with a view to reducing car journeys to school and the idling of car engines outside schools. This also links to other wider strategies that encourage a more healthy lifestyle for children.
  - Leading by Example – improving emissions from the Council's fleet of vehicles.
  - Reducing Vehicle Emissions – take action to reduce idling vehicles and report smokey vehicles.
  - Improving Public Transport – work with our partners to improve public transport services.
  - Road Network Improvements – work with our internal and external partners and deliver road and traffic management improvements to the Boroughs road system in line with the West Midlands Local Transport Plan 2.
  - Land Use Planning Initiatives – ensure that through the planning system development is future proofed against air quality issues.
  - Industrial, Commercial & Domestic actions – control emissions through the enforcement of pollution control legislation.
11. An example of a ongoing project that already has had a positive impact on air quality is the Brierley Hill Sustainable Access Network (SAN) project has provided new traffic routes around Brierley Hill and numerous improvements to the highway network in the vicinity of Brierley Hill to assist good traffic flow. Air quality monitoring has now demonstrated a significant improvement in air quality in Brierley Hill High Street and elsewhere in the area previously designated as the Brierley Hill AQMA. All air quality monitoring at locations with residential exposure in the affected area are currently compliant with the National air quality objective for nitrogen dioxide and there has been a 16% reduction in the emission of this pollutant since the initiation of the SAN project.
12. The work carried out on air quality monitoring and the declaration of a whole Borough Air Quality Management Area and a subsequent Air Quality Action Plan is designed to reduce concentrations of specific pollutants to within National Objectives. This will have a positive impact on the environment, the health of all people residing and working within the Borough and the long term regeneration of the Borough, supporting the themes of the Dudley Community Strategy 2005 – 2020.
13. The proposal for adoption of the action plan was supported by The Select

14. Air Quality Monitoring work is funded from within existing budgets. There is no direct funding for the implementation of any part of the Air Quality Action Plan. The resources required for the activities identified with the Air Quality Action Plan are based upon partnership delivery and will be closely monitored as to their effectiveness.


15. Dudley Metropolitan Borough Council has a statutory duty under the provisions of Part IV of the Environment Act 1995 to review and assess air quality in its area
