APPLICATION FOR RENEWAL/TRANSFER AND VARIATION OF THE  
PUBLIC ENTERTAINMENTS LICENCE - THE THORNS INN, 174  
THORNS ROAD, QUARRY BANK

A report of the Director of Law and Property was submitted on an application made by John Gaunt and Partners, Solicitors, on behalf of Mr M A Williams (Tenant), for the renewal, transfer and variation of the public entertainments licence in respect of the premises known as The Thorns Inn, 174, Thorns Road, Quarry Bank.
