Purpose of Report

13. Developments

- The Access to Maternity Services review was published and was presented to the DGOH Executive. The document was well received and a report containing how DGOH would respond to the relevant recommendations published and considered at a DGOH board meeting. It is intended that the recommendations laid out in the review are to be implemented by the Improving Maternity Care Project Implementation Group set up by the Primary Care Trusts and Dudley Group of Hospitals. Exact details of the method and progress of the group's response to each of respective recommendations will be brought to light in a 'follow up' review to be implemented in the near future.
- The draft set of recommendations have been formulated following the Wheelchair Services Review. These are to be considered by the project board once the feasibility and responsibilities of the recommendations have been agreed between scrutiny and the health services.
- That proposal to include a standard item on future agendas of the Committee so as to facilitate members of the public asking questions on any matter falling within the terms of reference of the Committee has now been endorsed and is now a permanent feature on all agendas. To give the widest possible coverage of this opportunity advertisements have been placed in various newspapers and other branches of the media.
- Meetings have been held with the Chairmen and Chief Executives of the Health Services Trusts. Further meetings are planned.

- Representatives of the Select Committee have attended meetings of the Patients Forums, board meetings of the PCT and DGOH, meetings of Health Scrutiny Chairs forum and Centre for Public Scrutiny seminars and conferences.
- The work of the Committee has been advertised in a variety of ways including Local Area Committees. The Scrutiny section of the website has been updated and made easier to navigate to and around.
- Members have listened to a series of presentations from officers of the Health Service and Social Services and have received regular updates about developments in health and social care and about the principles and practice of scrutiny.

Finance

14. There are no direct financial implications arising from this report at this stage.

15. The requirement for the Committee to make an annual report to the Council is contained in Article 6 of the Constitution.
