NOMINATION OF WORKING GROUP MEMBERS 2006/2007

Purpose of Report

1. That the Select Committee consider and discuss the nomination of Members of the Select Committee to sit on the Working Groups.

Background

- 2. Article 6 of the Council's Constitution requires Select Committees to report annually to the full Council on the progress achieved in the previous year by the Committee and its Working Groups.

- 7. Since Working Groups do not have the status of formal Committees, the rules of proportionality which relate to seats on Committees under Section 18 of the Local Government and Housing Act, 1989 and the

Local Government (Committees and Political Groups) Regulations, 1990 are not applicable.
