3 APPLICATION FOR VARIATION OF STREET TRADERS CONSENT – MR H JONES, HALESOWEN TOWN CENTRE

A report of the Interim Director of Law, Property and Human Resources was submitted on an application, received on behalf of Mr Roberts (Site Manager), for the variation of the street traders permit to include a table and four chairs at the side of the hot dog vehicle on Hagley Street, Halesowen.

Mr R Roberts, Site Manager, was in attendance at the meeting as a representative for the applicant Mr H Jones.

Also in attendance and objecting to the application were Mr S Perry, Town Centre Manager, and Mr A Radford, Technician Engineer (Both of the Directorate of Urban Environment).

Following introductions, the Chairman outlined the procedure to be followed.

Mrs J Elliott, Licensing Officer, Directorate of Law, Property and Human Resources, presented the report on behalf of the Council.

Mr Roberts informed the Sub-Committee that the reason why the application had been submitted was to allow customers to consume their food in a sufficient and suitable area.

In responding to a question from Mr Perry relating to the positioning of the table and chairs, Mr Roberts confirmed that these would be placed in front of the vehicle.

The parties then withdrew from the meeting in order to enable the Sub - Committee to determine the application.
