Dudley Market	(1)	That the Strategic Director for Resources and Transformation and the Strategic Director for the Environment, Economy and Housing, in consultation with the Cabinet Member for Regeneration, be authorised to enter into an agreement on appropriate terms and conditions with a Traders Management Company for a pilot project for the management of Dudley Market.
	(2)	That a further report on the management of Dudley Market by the Market Traders be considered by the Cabinet after the first 6 monthly review and before the end of the 12 month pilot.
