# REPORT OF THE AREA LIAISON OFFICER

### **CAPITAL ALLOCATIONS**

### **Summary of New Applications by Ward**

#### **CASTLE & PRIORY WARD**

## 1. Youth Empowerment Scheme (YES)

The recommendation is that this group be awarded a capital grant of £2,117.80 to purchase computer equipment i.e. 4 laptops & 4 data travellers.

## 2. Senior Citizens Enterprise Woodwork Group

The recommendation is that this group be awarded a capital grant of £1023.60 to purchase woodworking tools including a router and table, planer, biscuit joiner, jigsaw and hand tools.

### NETHERTON, WOODSIDE & ST ANDREWS WARD

### 3. Woodside Community Association

The recommendation is that this association be awarded a capital grant of £1.037.82 to supply and fit an entry phone system to the internal entrance door of the Community Centre.

### 4. Arley & Compton Tenants Association

The recommendation is that this association be awarded a capital grant of £2,600.00 to replace 35 mts of tubular trip rail, including some landscaping work near to the entrance to Arley Court. This work to be carried out by Future Skills (DUE) if approved.

#### 5. Friends of Netherton Park

The recommendation is that this group be awarded a capital grant of £2,000.00 on behalf of Netherton Police Station, to purchase an additional two bicycles and equipment for Police Community Support Officers (PCSO's). (The grant will be paid directly to the Police, if approved).

## 6. Bowling Green Tenants & Residents Association

The recommendation is that this association be awarded a capital grant of £483.43 to purchase office furniture and equipment (List supplied).

### 7. Friends of Stevens Park – Quarry Bank via DUE

The recommendation is that DUE acting on behalf of this group be awarded a capital grant of £1,500 to supply and fix two benches in the war memorial rose garden of Stevens Park. DUE will carry out this work, if approved.

#### 9. Friends of Old Park School
