# REPORT ON THE PEOPLE'S MILLIONS £50 MILLION LOTTERY GIVEAWAY BLACK COUNTRY URBAN PARK

### **Purpose of Report**

1 To update the Area Committee on the Black Country's project in the 'People's Millions £50million Lottery Giveaway' – Black Country Urban Park and how to support the project in the public vote in late November/December. A DVD about the project will be shown at the meeting to support this report.

## **Background**

- 2 Black Country Urban Park is a £110m project, which aims to transform the Black Country through a series of flagship projects.
- 3 They are:
  - Strata Wren's Nest National Nature Reserve and the Seven Sisters Mines
  - Creating more accessible Canals focusing on Wolverhampton
  - The Green Bridge Park linking West Bromwich town centre and Walsall Arboretum through a 12 mile 'green bridge'
  - Living Landscapes 20 nature reserves or sites of public open space across the Black Country focusing on developing community projects for environmental improvements.
- 4 The main partners for the project are:-
  - Black Country Consortium
  - Dudley MBC
  - Sandwell MBC
  - Walsall MBC
  - Wolverhampton CC
  - Birmingham and Black Country Wildlife Trust
- At the time of the last Area Committee meeting, the Black Country was waiting for the Big Lottery Fund to finalise their assessment of the project and to make their announcement of who would be competing for the £50million.
- On the 23<sup>rd</sup> October 2007, it was announced that Black Country Urban Park had proceeded to the public vote to be held in late November/ early December.

- 7 Four projects will be part of the public vote:
  - Black Country Urban Park
  - The Edge The Eden Trust (St Austell)
  - Connect2 (people, places, pride) Sustrans (Bristol based, UK Wide)
  - Sherwood: The Living Legend Project (Sherwood Forest and surrounds)

## **Voting Process**

- 8 Supporters of each project will be able to vote on-line, by telephone and possibly text (although this has not yet been confirmed)
- 9 All voting will be overseen by the Electoral Reform Service (ERS). The telephone voting will charged at a local rate (10p -although calling from a mobile phone may cost extra).
- On-line voting will start on Monday 26<sup>th</sup> November. To vote on line, voters will need to register on the People's Millions website beforehand.
- 11 Telephone voting will begin at 9am on Friday 7<sup>th</sup> December.
- 12 A maximum of five votes per telephone number and email address will be allowed.
- 13 All voting will close at 12noon, Monday 10<sup>th</sup> December

## Promoting the project and encouraging people to vote

- A marketing and promotion campaign has been developed and is being currently being implemented. Co-ordination of the campaign is the responsibility of Black Country Consortium Ltd, with partners supporting this work or undertaking other activities where appropriate. Posters, postcards and other media promoting the TV vote are available for individuals, organisations and businesses to use to support the project.
- Dudley Museum & Art Gallery will have a detailed display of the Black Country Urban Park project for members of the public to visit and learn more. Dudley Museum & Art Gallery is open 10am 4pm Monday to Saturday. Libraries will also have displays and information about the project.
