31 TACKLING OBESITY – A FRAMEWORK FOR ACTION ANNUAL REPORT YEAR 5

A report of the Director of Community Engagement and Primary Care was submitted on work undertaken in relation to the Tackling Obesity Strategic Plan. A copy of the Tackling Obesity A Framework for Action Annual Report Year 5 had been circulated to Members and Officers separately to the agenda.

Arising from the presentation of the report the Chairman indicated that the withdrawal of some services was inevitable given the budgetary cuts and concern was expressed in that establishments that assisted with leading healthy lifestyles such as sports colleges and leisure centres would be closed, which would further contribute to the obesity problem.

In response to a query from a Member, the Joint Director of Public Health undertook to respond direct to the Member concerned about the services offered and work undertaken with regard to healthy eating in the Castle and Priory Ward.
