76 GAMBLING POLICY

A report of the Interim Director of Law, Property and Human Resources was submitted which sought consideration of the recommendations of the Licensing and Safety Committee, at its meeting held on 4th November, 2009, in relation to a review of the Council's Gambling Policy in the light of changes to the Gambling Commission's Guidance to Licensing Authorities issued in May, 2009. - (1) That the revised Gambling Policy, as attached to the report submitted to the meeting as Appendix 1, be approved, subject to the inclusion of the following amended wording to the second paragraph under the sub-heading (iii) Premises "ready for gambling" (Page 16 of the draft Policy), to read:-
 - "If the Applicant does not yet have a right to occupy or does not have an operators licence from the Gambling Commission then an application for a provisional statement should be made instead"
- (2) That, subject to the amendment in (1) above, the draft Gambling Policy, as set out in Appendix 1 to the report submitted to the meeting, be adopted for publication on 4 January 2010.
