# <u>THE REVISED DEPOSIT UNITARY DEVELOPMENT PLAN - PROGRESS TO DATE</u>

## 1.0 PURPOSE

1.1 To inform Members of the progress of the review of the Unitary Development Plan (UDP) for the Borough.

### 2.0 BACKGROUND

2.1 The current UDP for the Borough was adopted in November 1993. The Revised Deposit UDP was approved for publication at the Full Council meeting held on 21<sup>st</sup> January 2002. Prior to commencement of the Public Local Inquiry two sets of Pre-Inquiry Changes to the Plan were approved for publication. The first set of Pre-Inquiry Changes were approved by Full Council on 7<sup>th</sup> October 2002. The second set were approved by the Executive on 28<sup>th</sup> November 2002 under delegated authority given by Full Council on 18<sup>th</sup> November 2002.

The Public Local Inquiry into the objections/representations to the Revised Deposit Unitary Development Plan for Dudley MBC was held from 17<sup>th</sup> December 2002 to 12<sup>th</sup> June 2003.

- 2.2 The Inspector's report, detailing recommendations on the objections/representations made in relation to specific policies contained in the Plan, was received by the Council in January 2004. A report setting out the Inspector's recommendations and Dudley Metropolitan Borough Council's response to the recommendations was approved by the Executive Committee on the 17<sup>th</sup> March. The Inspector's Report and the Council's response were published in late March.
- 2.3 The Proposed Modifications to the Plan, taking account the Inspector's recommendations, were put on deposit for Public Consultation between 22<sup>nd</sup> October and 3<sup>rd</sup> December 2004. Officers are currently considering objections received during that consultation period. Further reports will be prepared in early 2005 which will seek approval to the Council's responses to objections received to the Proposed Modifications. Plan adoption is anticipated for mid 2005.

# 3.0 PROPOSAL

3.1 Members are asked to note the content of the report.

## 4.0 FINANCE

4.1 The costs of preparing the Revised Deposit Plan are met from budgets specifically identified for that purpose.

### 5.0 LAW

5.1 The review of the UDP is being prepared under Part 2 of the Town and Country Planning Act, 1990.
