Quarterly Corporate Performance Management Report

Purpose of Report

1. To present the second Quarterly Corporate Performance Management Report for 2008/09, relating to performance for the period 1st July to 30th September 2008.

Background

- 2. The over-riding purpose of the Quarterly Corporate Performance Management Report is to provide the Cabinet with a regular update on the management of services and performance levels being achieved within the Council, across the six Council Plan themes.
- 3. Prior to submission to Cabinet the report is scrutinised by the Cabinet Member Sub Group on Performance Management. This group has been meeting since the first quarter of 2005/06 and commissions more detailed exception reporting on any identified underperforming areas. A Quarterly Corporate Performance Summary is then produced from the group's discussions and circulated to all Members.
- 4. The report contains the following sections:
 - **Section 1** a brief introduction.
 - **Section 2** a performance summary and overview of the key achievements and issues affecting Dudley MBC during the second quarter of 2008/09, together with a summary of the key performance indicators for each Council Plan theme.
 - **Section 3** more detailed progress on the key performance indicators, key activities and risks included in the Council Action Plan 2010.
 - **Section 4** progress in the delivery of the Major Projects Programme.
 - **Section 5** performance of the LPSA stretch targets.
 - **Section 6** an overall picture of developments within the Council's partnership working.
 - **Section 7** information relating to the Council's current major net risks.
 - **Section 8** a budget statement.
 - **Section 9** workforce profile and sickness absence information.

Section 10 directorate reporting on key issues impacting upon Directorate Strategic Plan delivery; exception reporting on other performance indicators monitored by the directorates; and any other key issues.
