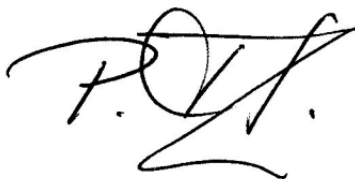

1. **COMMENTS OF THE CHAIRMAN**

7. SAFE AND SOUND DUDLEY'S COMMUNITY PARTNERSHIP ANNUAL REPORT 2011/12

A report of the Chief Executive was submitted detailing an overview of the work of the Community Safety Partnership (Safe and Sound), including information in respect of the performance of the partnership for 2011/12. The Partnerships priorities for 2012/13 were highlighted as reflected in the Community Safety Annual Plan for 2012/13. The names of the safe and sound board members, the partnership structure, partnership performance and the cost of safe and sound (Dudley's Community Safety Partnership) were Appended to the report submitted.

In presenting the report, the Chief Executive made particular reference to Appendix 3 to the report submitted which recorded the significant reduction in crime figures relating to dwelling burglaries, vehicle crime and robbery.

He also referred to the British Crime Survey, which had determined that recorded crime figures were accurate.

The strategic priority in relation to Troubled Families was referred to and it was noted that work would commence on a major initiative during a three year period, which was partly funded by the Government in order to address issues with troubled families.

The Chief Executive referred to the forthcoming election of a Police and Crime Commissioner and the Government funding that had previously been allocated to the Council by the Home Office and would in future be determined and allocated by the newly elected Police and Crime Commissioner.

In responding to Members questions the Chief Executive advised as follows:-

- That the British Crime Survey related to Households and not businesses, with businesses reporting crimes such as shoplifting directly to the Police;
- The initiative in relation to Troubled Families would address the amount of family members and the savings that could be made in relation to targeting issues and problems in relation to the same would also be measured;
- There would be no right of appeal in relation to the government funding allocated to the Council by the Police and Crime Commissioner;
- That an action plan would be implemented in relation to how to deal with troubled families which would be contributed to by a whole range of Public Sector Agencies with the main aim being to prevent or limit the problems in relation to those families and that by working closely with the above Agencies would alleviate previous defects in providing an efficient service relating to dealing with troubled families;
- That the work in relation to Troubled Families would not impact upon the funding and work of the Community Safety Team relating to the prevention of crime and crime reduction.
- That locally colleagues at a senior level in West Midlands Police were extremely competent and deployed resources in an efficient and effective manner and this may be an explanation for the reduction in crime.
- That neither the British Crime Survey nor recorded crime figures in this report gave details of detection rates or criminal justice outcomes.

The Drugs and Alcohol Team Manager reported that multi agency work was undertaken and partnership responses were made to reduce levels of re-offending which was currently by 18.06% below the predicted re-offending rate.

The Chief Executive advised that there were no trends in relation to the reduction of crime figures, other than the fact that year on year crime was reducing.

The Drugs and Alcohol Team Manager advised that in relation to the Community Safety fund there had been a reduction of 50% in Government funding for 2012/13 and in view of this £95,000 had been carried forward from the previous years budget and the decision to carry the funding forward had been taken by a multi agency working group.

**Report of the Chief Executive**

**Police Reform and Social Responsibility Act 2011**

**Purpose of Report**

1. The purpose of this report is to inform Members of the Scrutiny Committee of the appointment of the Police and Crime Commissioner, the Police and Crime Panel changes to the Community Safety Partnership landscape under the Police Reform and Social Responsibility Act 2011.

**Background**

2. The Police Reform and Social Responsibility Bill received Royal Assent on 15<sup>th</sup> September 2011. It brings about a number of changes in respect of the Community Safety agenda.
3. **Police and Crime Commissioners**
  - Will be elected on 15<sup>th</sup> November 2012 and take up office on 22<sup>nd</sup> November 2012 (and each subsequent fourth year on the ordinary day of election in the year of election)
  - To have regard for the Strategic Policing Requirement issued by the Home Secretary
  - Will be responsible for the issuing of a police and crime plan
  - Will hold the Chief constable to account
  - Will set the force budget
  - Will appoint and where necessary remove the Chief Constable
  - May make a crime and disorder reduction grant to any person
  - Will have regard for victims
4. **Police and Crime Panels (Outside of London)**
  - The functions of the police and crime panel for a police area must be exercised with a view to supporting the effective exercise of the functions of the police and crime commissioner for the area
  - The Police and Crime Panel must review the draft police and crime plan, or draft variation, given to the panel by the relevant police and crime commissioner
  - The Police and Crime Panel must arrange a public meeting of the panel to be held as soon as practicable after the panel is sent the Policing Area's annual report
  - The Police and Crime Panel will be involved in the investigation of non-criminal complaints against the Police and Crime Commissioners

## **5 Composition of the Panel**

One of the statutory principles for the appointment of the panel is the duty to produce a Panel which achieves the “balanced appointment objective” i.e. the local authority members (when taken together): -

- (a) Represent all parts of the Police area
- (b) Represent the political make up of all districts, and
- (c) Have skills, knowledge and experience necessary for the panel to discharge its functions effectively

The composition of the West Midlands Panel was considered earlier in the year by the West Midlands Leaders and their proposal is that there should be a panel of 12 elected members in order to reflect the population and political balance of the West Midlands. The consent of the Home Secretary for a panel of 12 members has been sought and a decision is still awaited.

## **6. Changing the Community Safety Partnership Landscape**

The exact relationship between Community Safety Partnerships (CSPs) and the Police and Crime Commissioner (PCC) is not yet known. However what is known is that: -

- There will be a reciprocal duty to cooperate i.e. PCCs and Community Safety Partnerships and Community Safety Partnerships and PCCs
- There will be a duty to have regard to each others plans
- The PCC will have the power to call together CSPs
- The PCC will have the freedom to commission services from other bodies and agencies other than CSPs

## **7. Crime and Disorder Reduction (Chapter 8 of the Act)**

Clarifies that reference to crime and disorder reduction is reference to:

- Reduction of crime and disorder (including anti-social behaviour and other behaviour adversely affecting the local environment)
- Combating the misuse of drugs, alcohol, and other substances, and
- Reduction of reoffending

## **8. Preparing for the Police and Crime Commissioner**

Safe and Sound (Dudley's Community Safety Partnership) have had a half day event to:-

- Ensure that partners were fully aware of the Police Reform and Social Responsibility Act 2011 in relation to the Police and Crime Commissioner
- To enable the Community Safety Partnership to consider what it needs to do to prepare for the incoming PCC
- To agree an Action Plan for safe and sound

The Action Plan for the Partnership is being developed around four key themes: -

## **Strategic Framework**

- To include a description of our model of partnership working/governance arrangements
- Performance Management – How can we be better at measuring outcomes and effectiveness?
- How do we gather further evidence of what is working? (Scoping exercise)

## **Change Management and Risk Management**

- How do we manage change and risk?
- What will we collectively sign up to?
- To include horizon scanning – e.g. Probation/Community Sentence Reform

## **Community Engagement**

- How could we do this better?
- What Community Engagement Activity is already taking place that we could “tap” into

## **Managing Relationships**

- Partners and providers
- PCC Candidates

### **9. Contribution to Regional Work**

There are links into this via the Chief Executive who is chairing the Community Safety Partnership Transition Workstream.

A profile is being prepared for Dudley to inform Police and Crime Commissioner Candidates of Community Safety Priorities for Dudley, to highlight performance, partnership working and evidenced based projects that have reduced crime, disorder and substance misuse.

### **10. Communication**

Locally, awareness raising in respect of the role of the Police and Crime Commissioner will be part of Safe and Sounds Annual Consultation Event (Face the People) which is taking place on 27<sup>th</sup> September, 2012.

Nationally, the Home Office will be running an advertising campaign in October. The campaign will target the public in England and Wales (excluding London) and will include TV advertising and other media channels

## **Finance**

11. There are no immediate financial considerations arising out of this report. However, it should be noted that in 2013/14 all Home Office Funding streams will go to the Police and Crime Commissioner. This includes the Community Safety, (Currently £152,924) Home Office contribution to the Drug Intervention Programme (currently – £235,284) and Home Office funding that is allocated to

the Youth Offending Service £63,000

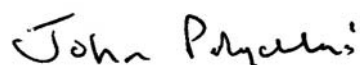

**Report of the Chief Executive Officer**

**Domestic Abuse Service Improvement Review Update.**

**Purpose of Report**

1. The purpose of this report is to update the Scrutiny Committee in respect of the Domestic Abuse Service Improvement Review.

**Background**

2. Domestic Abuse is an under reported crime. The extent of under reporting is unknown, although historical data from a 1999 research document<sup>1</sup> suggests that only 12% of incidents were reported as crimes.

The number of domestic abuse non crime incidents recorded by the police for Dudley Borough was 2900 during 2011/12. This was a decrease of 99 (3.3 %) on the previous year. The number of domestic abuse crimes recorded for the same period was 880. This was a decrease of 112 (11.3%) on the previous year and an overall total reduction of 211 (5.2%)

**Review**

- 3 Domestic Abuse remains a priority for partners in this borough. To ensure that the best services are delivered to this very important area of work a Domestic Abuse Service Improvement Review was initiated by safe & sound in collaboration with Dudley's Safeguarding Children's and Adults Boards and Supporting People. The aims of the review were to: -

- Map service provision
- Identify gaps
- Identify risks associated with gaps
- Inform future commissioning arrangements
- Review the Domestic Abuse Forum
- Inform the Domestic Abuse Strategy refresh.

4. The review has been presented to safe and sound strategic board, Safeguarding Children's Board and Safeguarding Adults' Board. The report highlighted a number of gaps, which are now subject to an ongoing action plan (**Appendix A**). This plan will drive the work necessary to reduce the gaps and minimise risks

**Brief Findings**

---

5. The review was conducted by a Project Team and the findings are the contribution of all the partners taking part in this review. A number of issues were highlighted and have been identified in the following categories.
- **Accommodation**- Improving accommodation shortages and increasing opportunities for affordable accommodation.
  - **Data Collection** – Improve shared intelligence, improve opportunities to target resources and strive to improve services by having joined up information systems.
  - **Engagement** - A number of outcomes identified the need to engage with hard to reach groups including Black Minority Ethnic and Lesbian Gay, Bi-sexual, Transgender victims and hard to reach through locality.
  - **Service Provision** – Outcomes to address blockages in current systems enabling improvement in capacity.
  - **Training** - Training to be implemented where gaps found
  - **Marketing** – Myriad of referral pathways to be unravelled and put into a simple directory.
  - **Funding** - Continual improvement of addressing funding against priorities.
  - **Other** - Various other outcomes including the refresh of the Domestic Abuse Strategy and reengineering of the domestic abuse forum against the evaluation.

### **Progress so far**

6. Improving accommodation shortages and increasing opportunities for affordable accommodation was identified in the review.
7. During 2010/11 the Homelessness Prevention services received a total of 2,223 enquiries and as a result of those 188 households were accepted as a full duty homelessness acceptance, where the local authority assists them to access housing or provides housing. 'Relationship breakdown' continues to be Dudley's primary cause of homelessness and of particular concern is the level of violent relationship breakdown that is occurring. A total of 46 households were accepted as homeless as a result of relationship breakdown and of those 39 were as a result of violent relationship breakdown. Some of these households will be temporarily placed within the refuges or other temporary accommodation or sometimes they are re-housed directly into a local authority or housing association tenancy.
8. From 1<sup>st</sup> January 2010 to mid December 2010 CHADD which is the main provider of refuge accommodation in the Borough has provided accommodation for 93 women and 123 children who were fleeing domestic abuse. An additional 147 women and 235 children were referred but could not be accommodated.
9. Although accommodation issues have improved with the opening of the new refuge this has not provided additional accommodation but has brought about an improvement in facilities. Due to the very flexible and uncertain demands made by victims of domestic abuse it is not possible to say how much extra accommodation is required.

- 10 Funding has also been provided to enable fleeing victims to secure private rented accommodation deposits quicker and the Staying Put scheme reduces the volume of victims who become homeless by allowing a victim to stay in their own homes.
11. The review found the following gaps in data collection and work is ongoing to reduce these:-
- During 09/10 DACHS received 538 contacts from 479 clients. At this time there were no processes to identify domestic abuse from these referrals. This has now been rectified.
  - No Accident and Emergency data is being shared. This is a national problem and is currently subject to a Government audit on data sharing.
  - We are unable to establish extent of GP data sharing and this will require further work.
- 12 Relationships have been forged between the partnership analyst and children's services and work is ongoing to enabling evidence based targeting of resources.
- 13 Anecdotal evidence from some service providers report that they were not engaging with the hard to reach groups despite many having processes in place to do so. Minimal evidence could be found of any BME engagement in the north of the borough with the south adequately covered.
- 14 To address this, engagement has been improved with the opening of a new service operated by Churches Housing Association Dudley District (CHADD). The domestic abuse self help group operates to encourage all victims to seek support and provides access to service at a number of locations throughout the borough at a time and location to suit.
- 15 Additionally, Community Development workers and the Lye Project are now linking with the Access service to provide support across the Borough and translator services are available to all Dudley residents free of charge to access Public Services.
- 16 The refresh of the domestic abuse strategy, improvements in web site signposting and a directory of services is also underway.
- 17 Service provision has improved but still remains work in progress. MARAC (Multi Agency Risk Assessment Conference) underwent an Ofsted inspection and as a result of the recommendations improvements in service delivery and training have been made. Funding has been made available for a MARAC co-ordinator to enable a more robust management of MARAC duties.

- 18 Extra funding has been found to continue Barnardos service provision and there are currently plans in progress to open a new regional SARC (Sexual Assault Referral Centre) with financial contributions from Dudley.
- 19 Changes to immigration rules in April of this year have brought about the Destitution Domestic Violence (DDV) Concession which will have an effect on those victims presenting to services who have no recourse to public funds. The extent to which this will effect future service provision will have to be subject to further work.
- 20 There is no perpetrators' programme in the borough although access to the Walsall S.A.F.E scheme has been agreed. The project board agreed that further work needs to be undertaken to establish the effectiveness of perpetrators programmes and learn from the current ongoing national evaluations
- 21 The Domestic Abuse Forum has delegates from directorates and agencies around the borough with a collective agenda of improving domestic abuse service delivery. It is a voluntary group different from many neighbouring forums that are a collection of paid service providers operating under one roof.
- 22 A new chair has been appointed the Domestic Abuse Forum and future discussions will be had on how best the forum will deliver appropriate outcomes.
- 23 Training has progressed and is progressing. A range of staff have received the nationally recognised Co-ordinated Action Against Domestic Abuse (Caada) training as part of their involvement in MARAC and as part of the recommendations from Ofsted.
- 24 Staff within Directorate of Adult Community and Housing Services are now dealing more routinely with forced marriage situations. They have attended training sessions and the Access Team are liaising more closely with the West Midlands Police - Public Protection Unit to deal with relevant issues.
- 25 Marketing of the Domestic Abuse agenda is referred to in detail on the partnership website although there is still some work to be completed. A comprehensive directory of services is currently being progressed to enable anyone to be signposted to services. In particular signposting through Dudley Council Plus and all other agencies is being progressed.
26. Funding has been provided through the Crime Reduction Implementation Group to reduce some of the gaps. There is still some work to do to seek funding to retain services currently paid for from partnership funding not helped by the uncertainty of the implementation of the Police and Crime Commissioners.
- 27 Work is currently being undertaken on the refresh of the Borough Domestic Abuse Strategy. A draft of this will be presented to the safe and sound board on 3<sup>rd</sup> Sept 2012.



## **Finance**

- 28 The Council does not provide any base budget funding specifically for Domestic Abuse except for providing a Domestic Abuse Co-ordinator's post. A number of directorates have business plans that encompass the area of safety including domestic abuse.
- 29 Projects and initiatives to tackle domestic abuse are mainly funded from Safe and Sound Partnership funding which has decreased over the years. Members should be aware that future delivery of domestic abuse services instigated by Safe & Sound will be subject to financial arrangements put in place by the Police and Crime Commissioner from April 2013 and this may not be sufficient to reduce the gaps or increase service provision capacity.

## **Law**

- 30 The relevant legislation on Domestic Abuse is the Offences against the Persons Act 1861 and the Sexual Offences Act 2003. The Crime and Disorder Act 1998 and subsequent amendments are also relevant to this report.

## **Equality Impact**

31. When the review was undertaken a Stakeholder Event was held to ensure that the review was relevant to the communities of Dudley. Other means of consultation were also used including a questionnaire delivered to all relevant domestic abuse service providers and one to one victim discussions.

## **Recommendation**

- 32 It is recommended that the content of this report and progress made to date in improving service delivery of domestic abuse services be noted.
