Dear Mr Freeman

Today, Ruth Kelly, Education Secretary, announced the results of the 2006-2009 Targeted Capital Fund (TCF). As you know, this is intended to meet schools' priority building needs which are too large to be supported from formulaic programmes, and too urgent to wait for Building Schools for the Future.

The amount allocated today is £1.1 billion, and is part of a schools' capital allocation of some £5.5 billion this year, rising to £6.3 billion by 2007-08. The outcome of bids received from you, and any Voluntary Aided bids or other allocations, is shown in the annex to this letter.

In respect of successful bids, projects are required to adopt best principles in project procurement, using the Achieving Excellence in Construction Procurement Guidance Pack and common Minimum Standards. Details of these are shown at <a href="http://www.ogc.gov.uk/index.asp?id=218">www.ogc.gov.uk/index.asp?id=218</a>.

The TCF bids that succeeded were those which met our published criteria most closely. These were; a) projects covering one or more of curriculum need, standards-focused reorganisation, SEN projects and extended schools/community use; b) workforce reform; c) wider inclusion agenda; d) building need; and e) value for money

Jacqui Smith, Minister for Schools, sends her congratulations to over 130 authorities and Voluntary Aided schools who succeeded in their applications. She also appreciates the time and effort put in by those who were not successful this time round, and the disappointment they will feel.

The minister is concerned that, particularly in respect of bids that did not succeed, feedback is made available to authorities and schools. This is in order to ensure that authorities and schools can prepare the best case possible in future rounds. Accordingly, I will send feedback out shortly to all authorities who had one or more unsuccessful bids, also to VA schools.
