Chapter 1 – Introduction

Setting the scene

- 1.1 In April 2008, Dudley Council began work on the Stourbridge Area Action Plan. The Area Action Plan (AAP) will set the planning framework for the area, which will include Stourbridge Town Centre High Street and Lower High Street (located inside Stourbridge Ring Road), and existing employment areas to the north of Stourbridge Ring Road and established mixed development areas located to the south. The Area Action Plan, when adopted, will be the basis on which planning decisions are made within the area.
- 1.2 Two separate AAP boundaries are being proposed as part of this draft Options document consultation. Proposed boundary 1 covers Stourbridge Town Centre High Street and Lower High Street located inside Stourbridge Ring Road, and extends north to include existing employment areas at Mill Race Lane Trading Estate and Old Wharf Road, and extends south to the Union Street and Hagley Road junction. Proposed AAP boundary 2 covers a significantly reduced land area, focusing more on the core of the town centre (inside the ring road) and immediately adjacent industrial areas located on the northern edge of the ring road. Maps showing the extent of both proposed boundary options can be found in Chapter 6 (Issues, Opportunities and Challenges)) of this document.

1.3 The Area Action Plan will:

- contain a vision for what we want to achieve in Stourbridge;
- co-ordinate transport and public realm proposals in the town centre;
- Identify opportunities to deliver new development, growth and regeneration;
- The AAP will set out a strategy for its development and regeneration and will allocate sites within the AAP boundary for certain uses
- Protect areas particularly sensitive to change. For example areas of Historic interest and nature conservation sensitivity.
- Identify short, medium and long term actions to manage growth and change. For example, the AAP will consider how the growth of the town centre should be proactively phased and implemented.

How to use this Document

1.4 This document presents you with the key issues in Stourbridge and sets out some options for how the strategy should be developed. It is, first and foremost, a consultation document. Throughout the later sections you will find questions which are intended to get you thinking about how you consider Stourbridge should develop and what approach should be taken to the different areas within the centre. - 1.8 Your views would also be welcomed on the Baseline Report, a dynamic document containing data and evidence relating to the production of the Stourbridge Area Action Plan. 
Why do we need an Area Action Plan?

- 1.9 The Planning and Compulsory Purchase Act 2004 transformed the system of development planning in order to create a more holistic planning system. The new planning system aims to speed up the planning process, making it more flexible and responsive to changes in local circumstances and enabling a greater degree of public engagement at all stages in plan-making.
- 1.10 The new system brought about a process whereby the existing Dudley Unitary Development Plan (UDP) would be gradually phased out and replaced with a Local Development Framework (LDF). This would be made up of a Statement of Community Involvement (SCI), and Annual Monitoring Report (AMR) and a Local Development Scheme and a series of Development Plan Documents (DPDs) and Supplementary Planning Documents (SPDs). - 1.11 Area Action Plans (AAPs) are a type of Development Plan Document (DPD) which are deemed appropriate for town centres or specific areas where significant change or redevelopment is anticipated. Dudley Council are preparing this Area Action Plan (AAP) for Stourbridge for the period at least up to 2026 as a great degree of investment and

change is proposed in the area. The future for Stourbridge is exciting and challenging and there is a clear need to develop this Area Action Plan to enable growth and development to proceed. Further details about how this Area Action Plan fits into the planning framework for Dudley can be found in Figure 1 below.

1.12 This Stourbridge Area Action Plan (AAP) will be prepared in the following stages:

April 2008 - January 2010

Research, evidence gathering and front loading engagement.

<u>February 2010 – April 2010</u>

Issues and Options stage (draft) AAP document – 6-weeks public engagement stage (and engagement on a Sustainability Appraisal (SA) of the options, which will be used to inform the final draft AAP document (Publication stage document)).

December 2010 - January 2011

Draft Publication stage AAP document. Public engagement stage which will inform the preparation of the draft Area Action Plan (AAP) for submission to the Secretary of the State

May 2011

Submission to Secretary of State and Statutory Public Consultation.

Review and monitoring

- 1.13 Most of the information gathered during the first phase of this process is contained within the Baseline Report.
- 1.14 This Stourbridge AAP emerging draft Options document report presents the issues and options which have arisen from the evidence gathering stage and frontloading consultation previously undertaken. This Stourbridge AAP draft Options document report will be subject to public engagement. The purpose of this report is to discuss the various options for the regeneration and development of Stourbridge. The engagement undertaken on the draft options document will be used to inform the draft "Publication Stage" Stourbridge AAP document, which is the next stage in the Area Action Plan process.

A Partnership Approach

- 1.15 Guiding regeneration within Stourbridge requires a co-ordinated and consistent effort. Substantial investment will be required from private sector partners and the public sector. These private sector partners include Stourbridge Chamber of Trade (comprising of local Stourbridge traders and other business owners operating within the town centre), Advantage West Midlands (AWM), major land owners within Stourbridge, Dudley Primary Care Trust (PCT), West Midlands Police, British Waterways, local colleges, Connexions, Jobcentre Plus and English Partnerships.
- 1.16 In Stourbridge, there is a history of partnership working. The Stourbridge Chamber of Trade and Town Centre Management group includes the Council, local Stourbridge Town Centre traders and other local businesses and meets on a bi-monthly basis to consider key issues and concerns affecting local traders and physical, social and economic regeneration matters connected to the town centre.
