<u>Dudley Borough Festival Working Group</u> – to consider proposals for inclusion in the Borough Festival. <u>Composition</u>: 4 members of the Conservative Group and one member of the Labour Group, together with any other member of the North Dudley Area Committee wishing to attend. <u>Membership</u>: Councillors Fraser MacNamara, Stanley, Evans, Mrs Ameson and Mrs Ridney.
