17. <u>Application for Review of a Premises Licence – News Express (The</u> <u>Wine Cellar), 15-17 Abbey Road, Gornal, Dudley.</u>

A report of the Interim Director of Public Realm was submitted for the review of the premises licence in respect of News Express (The Wine Cellar), 15-17 Abbey Road, Gornal Wood.

The following persons were in attendance at the meeting: -

A Singh – Premises Licence Holder and Designated Premises Supervisor

D Dadds LLP – Barrister A Singh's representative.

K Turley – West Midlands Police

R Jones – Enforcement Officer (Trading Standards)

M Beesley – Senior Trading Standards Officer (Environmental Health and Trading Standards)

K Maan – Principal Trading Standards Officer (Environmental Health and Trading Standards)

Following introductions, the Assistant Team Manager - Licensing and Waste Enforcement presented the report on behalf of the Council who advised that an application for review of the premises licence was received from Environmental Health and Trading Standards on 3rd January 2023, on the grounds of breaches to the licensing objectives in relation to the prevention of crime and disorder and the protection of children from harm.

It was noted that there were six letters from local residents in support of the premises.

It was reported that the premises had been the subject of a review by the Sub-Committee previously on 28th June 2022. As result of that review the following conditions had been applied to the premises licence:

- (1) Closed Circuit television (CCTV) is to be installed at the premises. This shall be capable of retaining images for 30 days. CCTV images must be made available for playback in store to the Police or Council Licensing Officers at any time the store is open. CCTV images must be provided to the Police or Council Licensing Officers within 48 hours of a GDPR compliant request.
- (2) A member of staff capable of operating the CCTV and downloading and/or playing images shall be present at the premises at all times when it is open.
- (3) A challenge 25 policy shall be operated at the premises.
- (4) All staff selling age restricted products shall be given training in the promotion of the licencing objectives and the challenge 25 policy. Refresher training shall be provided at least every six months. A record of training shall be maintained and retained for a period of at least three years. Copies of training records shall be provided to Council Licensing Officers within 48 hours of a request being made for them.
- (5) A log shall be kept detailing all refused sales of alcohol. The log must include the date and the time of the refused sale and the name of the member of staff who refused the sale. The log shall be retained for a period of three years. Copy of the refusal log shall be provided to Council Licensing Officers within 48 hours of a request being made for it.

R Jones presented the facts of the case referring to the breach in relation to the prevention of crime and disorder and the protection of children from harm, under the Licensing Act 2003, that had resulted in the application being made for the review of the premises licence.

Details of the underage purchase were noted, and R Jones referred to the recommendations of Environmental Health and Trading Standards.

K Turley then presented representations on behalf of West Midlands Police advising that the recommendations of Environmental Health and Trading Standards were supported.

Following questions and responses, Mr Dadds presented the case on behalf the Mr A Singh and in doing so advised that the application for the review of the premises licence should be considered on its own merits. It was stated that the premises in question consisted of a small shop with Mr A Singh being present for the majority of the time on the shop premises with one other in his employment.

It was noted that the employee who had sold the product to an underage purchaser had been dismissed as a result and there were no objections to a further condition being applied to the premises licence that the former employee be excluded from the premises

It was accepted that Mr A Singh was under an obligation to provide training to his employees, and it was noted that there was a robust system of training in place as referred to in the additional information provided by Mr Dadds which outlined the monthly training regime that continued to take place.

The evidence of Mr G Hicks, Licensing Consultant at Raven Consultants was referred to and it was noted that although that evidence related to the underage sale it was incoherent and Members agreed that the audio evidence was inaudible.

Members noted that Challenge 25 training had been provided to Mr P Singh, there were posters throughout the business premises in relation to the Challenge 25 policy, and sophisticated software had been installed to the cashiers till prompting shop assistants to request identification as part of Challenge 25 policy.

Mr Dadds asserted that no offence whatsoever had been committed by Mr A Singh.

As appropriate further responses were provided to questions from Officers and Members.

All parties were given the opportunity to sum-up their cases. The parties then withdrew from the meeting in order to enable the Sub-Committee to determine the application for review.

The Sub-Committee having made their decision invited the parties to return and the Solicitor then outlined the decision.

Resolved

That following careful consideration of the information contained in the report submitted and the information presented at the meeting, the following additional condition numbered (6) be applied to the premises licence operating schedule in respect of the premises known as News Express (The Wine Cellar), 15-17 Abbey Road, Gornal Wood:-

Mr. Parvittar Singh is excluded from the premises known as News Express (The Wine Cellar), 15-17 Abbey Road, Gornal Wood, Dudley.

Reasons for the Decision

On balance of probabilities, the sub-committee believed that the test purchaser was unlikely to have not stated his age correctly, and the audio recording was so poor, that this could not be confirmed either way.

Nevertheless, the seller did not follow best practice and did not ask for proof of age, for a purchaser who appeared to be under 25 on the video recording viewed by the sub-committee. The seller has been dismissed.

The sub-committee had seen good evidence that the premises license holder and Designated Premises Supervisor (DPS) had implemented training and updates for his staff, had installed an efficient till prompt system, had maintained training records, has operated a 'refusals register' and had displayed challenge 25 posters. The sub-committee was satisfied that the specific seller did not follow this training and these procedures, despite his training. The sub-committee was therefore satisfied that the premises licence holder had fulfilled his responsibilities, and therefore takes no steps to revoke the licence or remove the DPS. It has however found that the imposition of the proposed condition did address the issues raised by this review and places that condition into the operating schedule. of the premises licence. This condition was offered by the premises license holder, as a means of avoiding any future confusion about Mr Parvitter Singh returning to the premises in any capacity.

Application for Grant of a New Premises Licence

AFC Birmingham, Illey Lane, Halesowen, B62 OHF

<u>Purpose</u>

1. To consider the application for the grant of a new premises licence in respect of the premises known as AFC Birmingham, Illy Lane, Halesowen.

Recommendation

2. That the Sub-Committee determine the application for the grant of a premises licence in light of representations raised.

Background

- 3. On the 15th May 2023, an application for the grant of a new premises licence was received from Abs Rohomon BEM (authorised agent) on behalf of John Paul Baker in respect of the premises known as AFC Birmingham, Illey Lane, Halesowen. A copy of that application has been forwarded to the Committee Members and interested parties in accordance with the Licensing Act 2003 and is attached to this report as Appendix 1.
- 4. The application had the following documents enclosed:-
 - Plan of the premises
 - Correct fee
 - Consent of the DPS



5. The application for a premises licence is as follows:

Regulated Entertainment (Plays/Films)

Monday to Sunday 12.00 until 23.00

Supply of Alcohol and Regulated Entertainments (Live Music/Recorded Music/Performance of Dance)

Monday to Sunday 12.00 until 23.00

New Years Eve hours from start on 31st December until finish on 1st January.

Premises Open to the Public

Monday to Sunday 11.00 until 23.30

New Years Eve hours from start on 31st December until finish on 1st January.

- 6. Confirmation that copies of the application form and supporting documentation have been served on the relevant authorities has been received.
- Representations have been received from 4 local residents. Copies of the representations have been forwarded to the Applicant, Committee Members and Interested parties in accordance with the Licensing Act 2003 and are attached to this report as Appendix 2.

Finance

8. There are no financial implications.

<u>Law</u>

- 9. The law relating to the determination of applications for the grant of a premises licence is governed by the Licensing Act 2003, part 3, section 18.
- 10. Pursuant to Section 18(3) of the Licensing Act 2003, where a relevant authority has made representations, the Licensing Authority must:-

- (a) hold a hearing to consider them, unless the authority, the applicant each person who has made such representations agree that a hearing is unnecessary, and
- (b) having regard to the representations, take such of the steps mentioned in subsection (4) (if any) as it considers necessary for the promotion of the Licensing objectives.
- 11. Pursuant to Section 18 (4) the steps are:-
 - (a) to grant the licence subject to:-
 - such conditions as are consistent with the operating schedule accompanying the application modified to such extent as the authority considers necessary for the promotion of the licensing objectives, and
 - (ii) any condition which must under section 19, 20 or 21 be included in the licence;
 - (b) to exclude from the scope of the licence any of the licensable activities to which the application relates;
 - (c) to refuse to specify a person in the licence as the premises supervisor;
 - (d) to reject the application
- 12. Pursuant to Section 23(1) of the Licensing Act 2003 where an application (or any part of an application) is granted under section 18 of the Licensing Act 2003, the Licensing Authority must immediately give notice to that effect to:-
 - 1 (a) (i) the applicant
 - 1 (a) (ii) any person who made relevant representations in respect of the application and
 - 1 (a) (iii) the Chief Officer of Police for the police area in which the premises are situated and
 - 1 (b) issue the application with the licence and a summary of it

- 13. Pursuant to section 23(2) where relevant representations were made in respect of the application, the notice under subsection (1)(a) must state the authority's reasons for its decisions as to the steps (if any) to take under section 18(3)(b).
- 14. Pursuant to section 23(3) where an application is rejected under section 18, the licensing authority must forthwith give a notice to that effect stating its reasons for the decision, to
 - (a) the applicant
 - (b) any person who made relevant representations in respect of the application, and
 - (c) the Chief of Police for the police area or each police area in which the premises are situated
- 15. Where a Local Authority grant a licence under section 18 pursuant to schedule 5 of the Licensing Act, section 2 the holder of the licence may appeal against any decision:-
 - (a) to impose conditions on the licence under subsection (2)(a) or 3(b) of that section, or
 - (b) to take any step mentioned in subsection (4)(b) or (c) of that section (exclusion of licensable activity or refusal to specify person as premises supervisor)
- 16. Where a person who made relevant representations in relation to the application desires to contend:-
 - (a) that the licence ought not to have been granted, or
 - (b) that, on granting the licence, the licensing authority ought to have imposed different or additional conditions, or to have taken a step mentioned in subsection (4)(b) or (c) of that section, he may appeal against the decision.
- In pursuance of regulation 26(2) of the Licensing Act 2003 (Hearing Regulations 2005) the Licensing Authority must make its determination within 5 working days of the conclusion of the hearing.

 If the Licensing Authority refuse to grant the application, there is a right of appeal. The appeal under this part must be made to a Magistrates' Court pursuant to schedule 5 section 9 of the Licensing Act 2003.





Background

 The Broadway Service Station, was first issued with a premises licence on 1st July 2010, the current premises licence is in the name of Mr Piara Singh Virdee. The premises licence is issued for the following days and times:

Hours Open to the Public

Monday to Sunday 06.00 until 22.00

- 4. On the 18th April 2023, Mr Saman Haroon Mehmud made application for the transfer of the premises licence and vary of the DPS. A copy of both application forms have been forwarded to Committee Members and interested parties in accordance with the Licensing Act 2003 and are attached to this report as Appendix 1.
- 5. On the 27th April 2023, representations were received from West Midlands Police. Copies of the representations have also been forwarded to the applicant, Committee Members and interested parties in accordance with the Licensing Act 2003 and are attached to this report as Appendix 2.
- 6. This matter was due to be considered by the Licensing Sub Committee on 1st June 2023 however at the request of the applicants solicitor the matter was deferred to a future meeting in order for the applicants solicitor to prepare representations on behalf of their client.

- 20. Pursuant to part 3, section 37(6) the Chief Officer of Police must give that notice within the period of 14 days beginning with the day he/she is notified of the application.
- 21. Pursuant to section 39(3), the Licensing Authority must:-
 - (a) hold a hearing to consider it, unless the authority, the applicant, and the Chief Officer of the Police who gave notice agree that a hearing is unnecessary, and
 - (b) having regard to the notice reject the application if it considers it appropriate for the promotion of the crime prevention objective to do so.
- 22. Pursuant to regulation 26(1) of the Licensing Act 2003 (Hearing Regulations 2005), the Licensing Authority must make its determination at the conclusion of the hearing.
- 23. Where an application under section 37 is granted or rejected pursuant to section 39(4), the Licensing Authority must give a notice to that effect to:-
 - (a) the applicant
 - (b) the proposed individual, and
 - (c) the Chief Officer of Police for police area in which the premises are situated.

- 24. Pursuant to section 39(5) the notice must state the authority's reasons for granting or rejecting the application.
- 25. Pursuant to section 39(6) where the application is granted, the notice must specify the time when the variation takes effect.
- 26. Pursuant to schedule 5, part 1 1(c) if the Licensing Committee refuse to grant the application to vary a licence to specify individual as premises supervisor there is a right of appeal to the Magistrate's Court.
- 27. Pursuant to schedule 5, part 1 5(1) and (2) if the licensing Committee grants the application to vary a licence to specify individual as premises supervisor in a case where the Chief Officer of the Police gave notice under section 37(5) the Chief Officer of the Police may appeal against the decision to grant the application.

West Midlands Police wish to object to the transfer of premises licence to Saman Haroon Mehmud and the variation of DPS to Rebar Salar at Broadway Service Station (also known as Stourbridge Mini Market), 154 South Road, Stourbridge, DY8 3RW (DY/51/1261), under the Prevention of Crime & Disorder and Protection of Children From Harm licensing objectives.

On 11 April 2023, Trading Standards Officers conducted a Test Purchase operation at this premises, which resulted in the sale of a disposable vape to two 16 year females. They had also received intelligence that the premises were selling oversized vapes. Following the test purchase, Trading Standards Officers entered the premises where there was an unknown male present, stacking shelves. Trading Standards Officers explained the underage sale. Illegal vapes were seen in a display cabinet on the shop counter, therefore Trading Standards explained that they would be carrying out an inspection of the premises using their powers under the Consumer Rights Act 2015. At this point the male stated that he was phoning the owner. Trading Standards began carrying out a search behind the counter for illegal vapes. As well as those vapes in the display cabinet, there were more under the counter and three boxes of vapes on the floor, which they proceeded to seize.

Rebar Salar, the proposed DPS, then entered the premises. He was obstructive and aggressive and refused to provide his details. Mr Salah told Trading Standards that they could not take the illegal vapes without providing the shop with a notice first and that this was what had happened at his shop in Smethwick. Trading Standards advised that they had the powers to seize the vapes and therefore that is what they intended to do.

Mr Salah telephoned Saman Mehmud, the proposed Premises Licence Holder, who when put onto speaker phone made threats to Trading Standards Officers. Mr Salah began filming Trading Standards Officers and stated that he would upload the video to social media. Trading Standards continued to seize the vapes at which point Mr Salah assaulted one of the Trading Standards Officers. This investigation is currently ongoing. Police Officers attended and the vapes were seized. The attached statement from Mark Beesley, Trading Standards Officer, provides a full account of the operation and subsequent incident.

On 18 April 2023, Trading Standards seized an illegal vape and a packet of counterfeit cigarettes from the premises. Following the seizure, Trading Standards Officers intended to conduct a full inspection of the premises under the Consumer Rights Action 2015, however, they were unable to gain access as the roller shutter on the shop had been pulled down and locked to prevent entry via the door that the Officer used earlier.

On the basis of the above, West Midlands Police strongly object to both the transfer of premises licence and variation of DPS, as not only have Saman Meluh and Rebar Salar failed to uphold the Prevention of Crime & Disorder and Protection of Children From Harm licensing objectives, but are also currently under investigation by Trading Standards for the following offences of Trademarks Act 1994, Fraud Act 2006, Tobacco & Related Products Regulations 2016 and Standardised Packaging of Tobacco Regulations 2015. Mr Salar is also under investigation by West Midlands Police for Common Assault on 11 April 2023.

During the course of the search a large amount of counterfeit cigarettes and illegal oversized vapes were recovered from a motor vehicle and residential property, both of which were associated with the shop premises and the business operators. A criminal investigation has commenced against all parties connected with the business itself and the owners of the properties concerned

Application for Renewal of Consent to Engage in Street Trading

Mr Muhammad Ikhlas – Build A Burga Ltd.

Purpose

1. To consider the application made by Muhammad Ikhlas (Build A Burga Ltd) for the renewal of a consent to engage in street trading in Dudley Town Centre.

Recommendation

2. That the Committee consider this application for the renewal of a consent to engage in street trading for the sale of Burgers in Stone Street Square, Dudley, following the receipt of representations.

Background

- On the 23rd May 2022, an application was received by the Licensing 3. Office from Mr Ikhlas for the grant of a consent to engage in street trading in Stone Street Square, Dudley, to sell Burgers, Fries and Canned Drinks. Monday to Sunday 12.00pm until 11.00pm.
- This matter was considered by the Committee on the 2nd August 2022, 4. When comments in respect of the application were received from Environmental Health and Trading Standards, Traffic Transportation and Engineering Services and Placemaking (Regeneration and Enterprise), the Committee resolved that a consent to engage in street trading in Dudley Town Centre be approved subject to the relevant Department to confirm in writing the precise location on which the applicant could trade at Stone Street Square, Dudley.

- 5. On the 20th March 2023 an application to renew the consent from the 2nd August 2023 was received by the Licensing office.
- That application together with details of the proposed site and photograph of the trading vehicle were circulated to Committee Members and interested parties, and are attached as Appendix 1 to this report. Details of the application were also posted on the Council's Webpage.
- 7. Comments in respect of the application were received from 3 Ward Councillors, Corporate Landlord Services, Street Green Care and Amenity Services and Environmental Health and Trading Standards and are attached to this report as Appendix 2.

Finance

8. There are no financial implications.

<u>Law</u>

- The grant of consents to engage in street trading is governed by Part III of Schedule IV to the Local Government (Miscellaneous Provisions) Act 1982. To trade without such consent is an offence.
- 10. Paragraph 7(2) of Schedule IV of the 1982 Act, states that the Council may grant a consent if it thinks fit and, when granting or renewing a consent, the Council may attach such conditions as it considers necessary.
- 11. Paragraph 10 of Schedule IV of the 1982 Act, states that a street trading consent may be granted for one period not exceeding 12 months but may be revoked at any time.
- 12. Where the consent allows the holder to trade from a cart, barrow, or other vehicle, then the consent must specify the location from which they may trade and the times between which or periods for which they may trade.
- 13. There is no right of appeal against the Council's decision to vary a condition upon which consent is issued, or refusal to grant or renew a street trader's consent.



Hi Gale,

As the landowner We understand this area is not designated public highway and is owned and maintained by the council as public space.

As Landowner we would object to this continuing presence of the burger van and the proposed renewal of a licence to trade in this location- kindly note we would have objected to it being granted in the first instance had we been aware of the proposal at that stage – the reasons being set out below:-

I recently became aware of at least 3 grease spillages into the squares drains the only source of which has got to be the burger van as the evidence on the ground is in close proximity to where the van is placed. Such spillages into the public drains network will end up with the council as landowner having to clear this up at its expense. I have no idea the reason or cause for such spillage or the specific dates they may have occurred or what attempt may have been made to clean up after by the licence holder.

Furthermore the council as landowner of the glasshouse has recently agreed terms to relet the former glasshouse restaurant for use as a good quality restaurant which is opening shortly and having the presence of such a burger van going forward is not in the council's best overall interest as landowner of both the square and the buildings fronting the square. We appreciate this may be seen to be a different offer to the restaurant but its presence is to the detriment of the restaurant position and will impact its trading offer

In addition the council is in detailed discussions in respect of the redevelopment of the businesses around the square anticipated to commence in the very near future, amounting to a proposed

im investment. The presence of the burger van in this location is not welcomed as it will not be in keeping with the degree of investment and the future uses of the square and similarly to the glasshouse will impact on the proposed uses for the remaining council buildings fronting this square.
