Notice is hereby given in accordance with section 29(1) of the School Standards and Framework Act 1998 that Dudley Metropolitan Borough Council intends to discontinue Holt Farm Primary School, Holt Road, Halesowen, West Midlands, B62 9HG from 31 August 2006.

Places are available for children from Holt Farm Primary School at Hurst Green and Olive Hill Primary Schools.

The planned admission number for reception at Olive Hill Primary School will be increased to 60 from September 2006. The planned admission number for reception in September 2006 at Hurst Green will remain at 55 until additional capacity is created (academic year 2006/2007) to enable an increase to 60 and a total capacity for 420 children. From September 2006, it is proposed that the Holt Farm site will become a temporary annexe of Hurst Green Primary and provide for those children who have expressed a preference for Hurst Green Primary until consolidation on a single site in 2007.

The Governing Body of Hurst Green Primary will assume responsibility for the annexe. The headteacher of Hurst Green Primary will be responsible for the overall leadership and management of both sites. Holt Farm staff will become part of the Hurst Green staffing establishment. Holt Farm pupils will transfer to the roll of Hurst Green Primary and remain on the present site until they transfer to the single site.

The current Authority's Transport policy will pertain to address any issues.

Discontinuation of Holt Farm Primary School

Dudley Metropolitan Borough Council, being the Local Authority, hereby gives notice in accordance with Section 29(1) of the School Standards and Framework Act 1998 that it intends to discontinue Holt Farm Primary School, Holt Road, Halesowen, West Midlands, B62 9HG from 31 August 2006.

It is proposed that pupils of primary school age (5 - 11 years) who will be displaced as a result of this proposal will be eligible to attend a number of primary schools located within the area and are closest to Holt Farm Primary School. These include:

- Hurst Green Primary School
- Olive Hill Primary School

In addition those pupils of Nursery age (3 - 5 years) who attend the Nursery class will be considered alongside those pupils of statutory school age and may be offered places in the area at Olive Hill Primary School, other primary schools or other providers.

The Authority will continue to work closely with parents and potential recipient schools and others to manage the transfer of pupils to these alternative schools in a sympathetic and practical way. Transport arrangements will be in accordance with existing Council policy.

Although there is a high number of available places in Halesowen primary schools there is a need to increase the number of school places at the two nearest schools, Olive Hill Primary and Hurst Green Primary. The planned admission number at both schools will be increased to 60 from September 2007. The Holt Farm buildings will be used as temporary accommodation for a period not expected to exceed 12 months to enable essential construction work at Olive Hill Primary School.

Explanatory Notes

The proposal to discontinue Holt Farm Primary School is being made following consultation with governors, staff and parents and because:

- a) The live birth rate in Dudley has fallen by almost 20% since 1997;
- b) There are 3,500 surplus places in 82 primary schools which without action will rise to over 5,000 by 2009/10.
- Pupil numbers at the school have declined over the last decade creating
 127 surplus places representing 45% of the total at January 2006.
- d) The school receives £683 per pupil more than the average for primary schools in the borough.
