**Report of the Lead Officer to the Committee**

**Quarterly Corporate Performance Report**

**Purpose of Report**

1. To review and scrutinise the performance of the Council in relation to the activities relating to the terms of reference of this Committee for the third quarter of 2009/10, October to December, 2009.

**Background**

2. The Quarterly Corporate Performance Report for the third quarter of 2009/10 was submitted to the meeting of the Cabinet held on 10<sup>th</sup> February, 2010. The Cabinet approved the content and style of the report. A coloured copy of that report has previously been circulated to Members. Members may wish to also bring that copy with them to the meeting. A coloured copy of the extracted report in respect of those matters relating to the terms of reference of this committee has also been circulated separately to Members and the Lead Officer only.
3. Consideration was also given to the Quarterly Corporate Performance Management Report by the Member Performance Management Sub Group and it was agreed that the following information be specifically drawn to the attention of this Committee:-

Percentage of voids that are long term:-

At the end of quarter 1 there were 181 major works voids (51% of all voids) and 177 routine voids (49%). Total voids 358.

At the end of quarter 2 there were 171 major works voids (55% of all voids) and 143 routine voids (45%). Total voids 314.

At the end of quarter 3 there were 149 major works voids (50% of all voids) and 151 routine voids (50%). Total voids 300.

4. In accordance with Article 6 of Part 2 of the Constitution, the Committee is invited to review and scrutinise Council performance relating to the Terms of Reference of this Committee.


