Report of the Director of Finance

Area Based Grant

Purpose of Report

1. To outline the Government's new Area Based Grant (ABG) and propose arrangements for the future management of this funding stream.

Background

- 2. For a number of years the Government has funded a range of council activities through specific grants. These have been earmarked for specific purposes and the Government has required councils to report and in some cases be audited on the use of these funds. A number of these grants, totalling £5.3m, have been pooled in the Local Area Agreement (LAA) during 2007/8, but they have in practice continued to be used for the purposes for which they were awarded.
- 3. In parallel with the introduction of next-generation LAA's from April 2008¹, the Government is introducing a number of changes it says will remove barriers to partnership working and allow greater flexibility in resource allocation. One of these changes is the transfer of a number of specific grants into a non-ringfenced Area Based Grant (ABG). The ABG is accompanied by a breakdown of the funding streams that make it up and those funding streams are allocated according to specific policy criteria rather than general formulae. However, there are no conditions attached to its use.
- 4. In Dudley, 36 separate funding streams are going into the ABG. A number of figures are provisional at this stage, but the expected three-year allocation is £14.5m in 2008/9, £14.6m in 2009/10 and £13.8m in 2010/11. The funding, together with an outline of the purposes for which it is currently being used, is set out in more detail in Appendix A.
- 5. In addition to the funding set out in Appendix A, the Government intends to include Supporting People (a grant to fund supported living for vulnerable people) in the ABG from 2009/10, subject to the experiences of a number of pilot councils during 2008/9. Dudley has a Supporting People allocation of £6.5m and has been asked to be one of those pilot councils. On behalf of the Supporting People Commissioning Body, I have accepted the invitation to be a pilot council and we await further government guidance as to what this will mean in practice.

6. Further analysis of the ABG funding streams and on-going commitments shows the following:-

In practice, therefore, all of the ABG funding in 2008/09 is committed to existing programmes.

- 7. There are particular challenges around the management of the Working Neighbourhoods Fund (WNF). The Council currently receives Neighbourhood Renewal Funding (NRF) £1.8m in 2007/8 which is being used to fund neighbourhood management, support to the Dudley Community Partnership (DCP) and a range of projects carried out by the Council's partners, including voluntary and community organisations. With effect from 2008/9, the NRF is being replaced by the WNF. Under the new criteria for allocation, which focus on measures of worklessness, Dudley will only receive transitional funding of £1.1m in 2008/9 and £0.4m in 2009/10. Further work is, therefore, required to manage the impact on other activities previously funded from NRF.
- 8. Notwithstanding the issues outlined above, the new freedoms create an opportunity to review ABG programmes, in some cases, where appropriate, through improved partnership working. The quality of partnership working is expected to be a focus in the Government's Comprehensive Area Assessment (CAA) which replaces the Comprehensive Performance Assessment (CPA) in 2009.
- 9. It has been the practice that some, but not all, of the funding now included in the ABG has been allocated and managed by the Dudley Community Partnership through the Local Area Agreement. ABG is a Council grant and has, therefore, been incorporated into the proposed 2008/09 Revenue Budget and Financial Plans. Working effectively with partners and stakeholders remain a key Government and Council priority and it will, therefore, be necessary to continue to develop appropriate arrangements to ensure the views of the DCP are reflected in total future Council resource allocation and spending programmes, including the ABG.

Finance

10. This report is financial in nature and relevant information is incorporated in the body of the report. Due to the existing commitments and future fallout of funding outlined in this report, the ABG is currently unavailable for new spending plans. This will need to be reviewed as part of the 2009/10 Budget and Medium Term Financial Planning process.

Law

11. The Council's budget setting process is governed by the Local Government Finance Acts 1988 and 1992 and the Local Government Act 2003.

Equality Impact

12. The ABG will incorporate a number of grants that are currently funding services to children and young people. It is proposed that any future consideration of this funding be part of the Council's overall budget strategy. All members of the public, including children and young people, have the opportunity to take part in the Internet consultation on that strategy. It is also proposed that in future DCP should be consulted as part of the budget strategy. The Dudley Youth Parliament is specifically represented on the Executive Board of DCP.

Recommendations

13. It is recommended that Cabinet note the position in relation to ABG outlined in this report.
