Standards in Dudley Schools (2004 Key Stage 4 Results)

Purpose

- 1. To present the latest data available on the performance of schools in the Borough in relation to:
 - Key Stage 4 National Curriculum assessment
 - Key Stage 4 Ethnic Minority assessment data
 - Pupils in Public Care assessment data

Background

- 2. The results for individual schools can be found in the Key Stage 4 Performance Tables print-out that has been made available by the DfES and is enclosed with this report (Appendix 1).
- 3. The latest (January 2005) results available for 2004 are:

- 4. The percentage of 5+ A* C GCSE passes declined by 0.1% in 2004. The percentage of 5 A* G grades declined by 0.5%. There are new methods of calculating average points scores and value added information.
- 5. A new scoring system has been developed by QCA to allow for the inclusion of a much wider range of qualifications in a pupil's end-of-Key Stage 4 results. The new scoring system has led to significant changes in the way the average points score is calculated. In the old system, for example, a GCSE at grade G

was worth 1 point – in the new system it is worth 16. An A* in the old system was worth 8 points and in the new system 58 points. Over 3,000 qualifications have been given a point score and can be included in the calculations.

- 8. 'Value added' is a way of measuring the progress a pupil makes between one stage of education and the next. The progress a school helps pupils to make, compared to their different starting points, allows comparison between groups of schools with different pupil intakes.

The new point score, which was developed to allow the inclusion of the wider range of approved qualifications, has resulted in the need for the value added measure to be centred around 1000, instead of 100, as in previous years.

A value added measure of 1006.0 means that, on average, each of the group's pupils has achieved one grade higher in one GCSE than the average (median) pupil with similar Key Stage 3 or Key Stage 2 prior attainment. Similarly, a value added measure of 994.0 would suggest that, on average, the group's pupils have achieved one grade lower in one GCSE than the average (median) pupil with the same Key Stage 3 or Key Stage 2 prior attainment.
