At this juncture those present at the meeting stood in silent tribute to the memory of Mr Don Richardson, a local businessman involved in the regeneration of the Black Country, who had recently died.

24 <u>REGIONAL SPATIAL STRATEGY – ANNOUNCEMENT</u>

The Assistant Director Economic Regeneration announced that on Friday of last week the Department for Communities and Local Government had sent out a letter supporting amendments made to the Regional Spatial Strategy. Two of the major effects of this were that the potential for Brierley Hill to become a fourth strategic centre for the Black Country had been recognised and that of Dudley Town Centre to become a centre for tourism and culture and be a place of regional significance for tourism had been endorsed. Along with other proposals these would have a major impact on the regeneration and renaissance of the area.

The government proposals would now go out for consultation until 9th November, 2007 with final approval by the Secretary of State expected in the new year.

28 DISABLED EMPLOYEES AND THE PERSONAL DATA AUDIT

A report of the Chief Executive was submitted, arising from a request made at the last ordinary meeting of the Committee, on how "disability" was defined and on the results of the personal data audit. Arising from the consideration given to the content of the report submitted particular comments were made on the table in paragraph 7 of the report relating to the number of personal data audit returns that had been fully entered on to the PSE system by August, 2007 and the proportion of disabled employees in schools which remained low and out of phase with the rest of the Council's workplace. The possible reasons for this and steps that could be taken to remedy this were also raised.

RESOLVED

That the information contained in the report submitted, on how "disability" was defined and on the results of the personal data audit, be noted and that the Lead Officer be requested to contact the Director of Children's Services regarding the low proportion of disabled employees in schools with a view to taking measures so as to increase the number of returns from schools, for example by raising the issue at the Schools Forum, and explaining the purpose of and need for such data, so as to hopefully bring schools in line with the rest of the Council's workforce.

29 <u>PROGRESS REPORT ON REGENERATION OF DUDLEY TOWN</u> CENTRE

A report of the Director of the Urban Environment was submitted on progress to date in relation to the Regeneration of Dudley Town Centre.

Arising from the presentation given by the Head of Design and Projects on the content of the report submitted members asked a number of questions and a specific request was made for information in respect of the current position regarding the 9 opportunity areas for development work in Dudley Town Centre.

In response to this request the Assistant Director Economic Regeneration informed the Committee that a report was due to be presented to the Cabinet at its meeting to be held on 31st October, 2007 on the opportunity areas. He also commented on proposals in respect of Tower Street and King Street/Mill Street and elaborated on the position in respect of the Cavandish Quarter with particular reference to Cavandish House. With respect to Cavandish House members considered that there was a need to expedite the position in respect of this property.
