Report of the Director of Corporate Resources

Application for a Licensed Premises Gaming Machine Permit

Purpose of Report

1. To consider the application for the grant of a Licensed Premises Gaming Machine permit for four machines in respect of The Bramford Arms, Park Road, Woodsetton, West Midlands, DY1 4JH.

Background

2. The Bramford Arms holds a current premises licence for the following:-

Sale of Alcohol

Sundays to Thursday inc 11.00 – 23.00

Fridays & Saturdays 11.00 – 00.00

Regulated Entertainment (playing of recorded music/dancing/live music)

Monday to Saturday inc 11.00 – 23.30

Sunday 12.00 – 23.00

11.00 hrs New Years Eve to 23.00 hrs New Years Day

Christmas Eve, Christmas Day, Boxing Day, New Years Day, Spring & August Bank Holidays, Good Friday, Easter Saturday, Easter Sunday and Easter Monday. Proceedings and preceding day before a bank holiday, St George's Day & St Patrick's Day one extra hour.

Any other publicly declared holiday, one extra hour.

Late Night Refreshment

Fridays and Saturdays 23.00 – 00.00

- 3. The Local Authority licensing policy states as follows:-
 - If authorisation is sought for more than two category C or D machines the applicant will be required to attend a hearing to support the application. All plans submitted with applications for premises licences must set out the siting of each category C or D machine.
 - Parliament has placed no restrictions on the age at which such machines may be played (other than those in amusements arcades). It is, therefore, a matter for the discretion of the premises licence holder and any adults accompanying the children concerned whether they are entitled to play such machines. In the case of premises used exclusively or primarily for the consumption of alcohol, all children under the age of 16 will only be permitted entry to the premises if accompanied by adults. All such machines must be sited in accordance with the Gaming Act. Further advice will be given on receipt of application.
 - There is unlikely to be the need for a hearing where the application is for renewal of the existing permit for more than two machines or where the application is for the grant of a Licensed Premises Gaming Machine Permit at premises which already have an existing permit for more than two machines, and where that number is not increased.
- 4. On the 20th April 2012, an application was received from Town & Country Leisure Limited in respect of the Bramford Arms, Park Road, Woodsetton, for the grant of a Licensed Premises Gaming Machine Permit for four machines. A copy of that application has been forwarded to Committee members and interested parties in accordance with the Licensing Act 2003.
- 5. On the 3rd May 2012, an application for transfer of that licence was received from Town & Country Leisure Limited on behalf of Green King Retailing Limited.
- 6. The current licence holder of the premises licence is Greene King Retailing Ltd. The premises currently has a Licensed Premises Gaming Machine Permit which entitles them to have up to three machines.
- 7. This application falls within the Council's recent responsibility for liquor licensing which has a direct link to the Council's key corporate priority that safety matters.

Finance

8. There are no financial implications.

Law

- 9. Pursuant to schedule 13, section 283 of the Gaming Act 2005, the Council can grant a Licensed Premises Gaming Machine Permit.
- 10. Pursuant to schedule 13, section 283 4 (2) on considering an application for a permit the Licensing Authority shall:-

- (a) grant an application
- (b) refuse the application, or
- (c) grant it in respect of:
 - (i) a smaller number of machines than that specified in the application
 - (ii) a different category of machines from that specified in the application

or

- (iii) both
- 11. Pursuant to schedule 13, section 283 5
 - (1) a Licensing Authority may not attach conditions to a permit
 - (2) as soon as is reasonably practicable after granting an application a Licensing Authority shall issue a permit to the applicant.
- 12. Pursuant to schedule 13, section 283 5 (3) as soon as it reasonably practicable after refusing an application a Licensing Authority shall notify the applicant of:-
 - (a) the refusal, and
 - (b) the reasons for it
- 13. In pursuance of schedule 13, section 283 6 (2) a Licensing Authority may not refuse an application, or grant an application in respect of a different category or smaller number of gaming than that specified in the application, unless they have
 - (a) notified the applicant of their intention to refuse or grant the application in respect of
 - (i) a smaller number of machines than that specified in the application
 - (ii) a different category of machines than that specified in the application or
 - (iii) both, and
 - (b) given the applicant an opportunity to make representations
- 14. In pursuance of schedule 13 section 283 6 (3) a Licensing Authority can satisfy the opportunity to make representations by given the applicant an opportunity to make:-
 - (a) oral representations
 - (b) written representations, or

(c) both

15. In pursuance of schedule 13 section 283 21 (1) the applicant for a holder of a

permit may appeal to the Magistrates Court if the Licensing Authority:-

(a) reject an application for a permit

(b) grant an application for a permit in respect of a smaller number of

machines than that specified in the application or a difference category of

machines from that specified in the application.

Equality Impact

16. This report takes into account the Council's policy on equal opportunities.

17. The licensing of premises and individuals will impact on children and young

people through their attendance at licensed premises.

18. There has been no consultation or involvement of children and young people in

developing these proposals.

Recommendation

19. That the Sub-Committee give consideration to this application.
