6. REVIEW OF STREET TRADING CONSENT / PROHIBITED STREETS – MARKET STREET, STOURBRIDGE

A report of the Director of Corporate Resources was submitted on an application on behalf of Ms S Newell, Himley Manager, for the revision of the consent/prohibited streets in Dudley Borough to include Market Street, Stourbridge as a consent street in respect of Street Trading.

Ms Newell, Himley Manager, was in attendance at the meeting, together with a colleague and commented on the application, in particular, that the request made was to have the existing restriction removed for one day per year to allow stalls to be set up along the Market street highway as part of the Christmas Light Switch on Festival.

Following further discussion it was, RESOLVED

That, in the light of information contained in the report submitted and as reported at the meeting, the application on behalf of Ms S Newell, for the revision of the consent/prohibited streets in Dudley Borough to include Market Street, Stourbridge as a consent street in respect of Street Trading, be approved.

7. REVIEW OF STREET TRADING CONSENT / PROHIBITED STREETS – DUDLEY TOWN CENTRE

A report of the Director of Corporate Resources was submitted on an application on behalf of Mr P Coyne, Assistant Director, Economic Regeneration, for the revision of the consent/prohibited streets in Dudley Borough to include Castle Street, New Street, Union Street and Junction of Stone Street/High Street, Dudley as consent streets in respect of Street Trading.

It was noted that Mr Coyne, Assistant Director, Economic Regeneration, had forwarded his apologies for his non-attendance at the meeting.

Reference was made to the possibility of transferring responsibility of street traders to the Directorate of Urban Environment, as some Members considered that street traders should pay similar rates paid by Market traders. Following further discussion, the Legal Advisor undertook to discuss further with the Assistant Director of Corporate Resources.

Report of the Strategic Director of Resources and Transformation

Revision of Licence Fees

Purpose of Report

1. To consider the revision of fees for licences and consents (other than those where the fees are imposed by statute in respect of liquor licensing, gambling machine permits and lotteries and amusements).

Background

- 2. The fees for the various licences and permits administered by the Committee were last revised with effect from April 2014.
- 3. Fees received in respect of all licences or consents, are currently refunded if the application is withdrawn or refused.
- 4. In considering the revision of licence fees, the Committee may wish to compare the fees charged by the Council with those of neighbouring Councils. A table showing these comparisons is attached as Appendix 1.
- 5. Column (1) in Table A below shows the fees currently charged.

Column (2) and (3) show the effect on fees of various increases between 2% and 5%. The budget for 2015/16 (see paragraph 7) has been set based on cost inflation and estimated activity levels; a 2% overall increase will be sufficient to achieve this.

6. The Council is only permitted to set licensing fees up to the amount that can be ascertained as being the cost of administering the licensing function. However this does not apply to liquor licensing fees, which are set by the Secretary of State for Culture, Media and Sport. The cost of administering includes enforcement, the administrative and ancillary costs of issuing the licence and the ancillary costs relating to members meeting to determine certain licensing applications.

Finance

7. This report is financial in nature with any financial implications referred to in the background above.

The budget 2015/16 has been set as follows; the cost of licence administration includes enforcement and administrative costs of processing the licence but does not include any costs relating to Members.

- 8. Part III and schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982 regulates the grant of street trading consents.
- The Gambling Act 2005 part 8 212 and the Gambling Premises Licence fees (England and Wales) Regulations 2007 make provision for the fees payable to the Council.
- 10. The Gambling Act 2005 part 8 212 2 (c) provides for the publication of fees from time to time.

11. The proposals take into account of the Council's policy in relation to equal opportunities.

- 12. The Gambling Act 2005 will impact on children and young people through the licensing of Family Entertainment Centres.
- 13. There has been no consultation or involvement of children and young people in developing these proposals.
