<u>Feedback from the Local Government Association Conference 'Preventing Anti-Social Behaviour' – 21st November 2005</u>

Purpose of Report

 To feedback to Committee on the attendance of the Chairman, Councillor David Blood, together with Keith Mayou and Mohammed Farooq to the Local Government Association Conference 'Preventing Anti Social Behaviour' on the 21st November 2005.

Background

- 2. Anti social behaviour has been identified as a key issue for local communities, councils and the variety of agencies involved in responding to crime and disorder in their area.
- 3. A joint Local Government Association and National Community Safety Network Conference was arranged with the following key themes being covered by the Conference:-
 - Finding a balance between enforcement and prevention in developing anti social behaviour strategies
 - Hearing petitioners' views as to what needs to be done
 - Hearing views on the contribution of community involvement in addressing anti social behaviour and considering the implications for local leadership.
- 4. Speakers included Helen Murray, Head of Anti Social Behaviour Unit in the Home Office, Professor Mike Hough of the Institute for Criminal Policy Research, Henrietta Curzon Westminster City Council, Crime and Reduction Team, John Hedge, Thames Valley Partnership, Community Safety Director, Sarah Isal, The Runnymede Trust, Senior Research &

Policy Analyst, Dr Rosie Chadwick, Prevention Services Division of Crime Concern, Andy Mills, Director of the National Community Safety Network and Jean Chinery, Consultant National Community Safety Network.

- 5. Specific comments on the learning from the Conference can be reported verbally at the meeting and brief details are as follows:
 - Local solutions to local problems is a general theme to be supported,
 - There is a balance to be achieved between prevention and enforcement,
 - Further evidence is needed for analysis to determine the preventative impact of 'naming and shaming' in connection with Anti-social behaviour.
 - Case Studies research and analysis will assist in developing policies that impact on the causes of crime,
 - There is an emphasis to be prioritised for implementing 'preventative strategies'.
 - There was support for action to encourage local partnership and 'joined up' working across all agencies in delivering prompt responses when referrals are made.
 - The National Community Safety Network launched its Report and Action Plan detailing Key Issues and Recommendations concerning Anti-Social Behaviour (see attached document),
 - The approaches being implemented by Dudley M B C are consistent with the recommendations discussed at the Conference.
 The initiatives being taken and developed are considered to be leading and forward thinking.
