Co-opted Member

Purpose of Report

1. To consider the appointment of a co-opted member to represent the ethnic minority communities in Stourbridge.

Background

- 2. At its meeting on the 16th June 2008 the Area Committee deferred a decision on the appointment of a co-opted member to represent ethnic minority communities in Stourbridge.
- 3. Since that meeting I have received letters from Mr Abdul Qadus (Appendix 1) and Mohammed Saeed (Appendix 2) asking to be considered for this appointment.
- 4. The Committee is asked to consider these nominations and make an appointment.
- 5. Members are reminded that the Protocol for Area Committees permits the Area Committee to co-opt up to five persons on to the Committee for the period expiring with the conclusion of a municipal year. Co-opted members are entitled to speak at meetings but not vote.
- 6. The Protocol requires that the Committee, in appointing co-opted members, must have due regard to the extent to which persons to be co-opted represent interest of importance within the communities served by the Committee. There is a further requirement that co-optees shall not represent the views of any political party on the Committee. Furthermore, the Committee has previously decided that co-optees must not be employed by the Council or be members of a political party.

<u>Finance</u>

7. Co-opted members are entitled to receive travelling and subsistence allowances in accordance with Section 174 of the Local Government Act 1972 and a Financial Loss Allowance in accordance with Section 173(4) of that Act.

Law

8. Section 102(3) of the Local Government Act 1972, enables the Committee to appoint co-opted members.

Equality Impact

9. This report complies fully with the Council's policies on equality and diversity. The views of young people are represented through the appointment of one of the co-opted members.

Recommendation

10. It is recommended that the Area Committee consider the appointment of a coopted member for 2008/9 to represent ethnic minority communities in Stourbridge.
