### **APPLICATION FOR A PREMISES LICENCE – GORNAL DYNASTY, 105 KENT STREET, UPPER GORNAL, DUDLEY**

A report of the Director of Law and Property was submitted on an application received from Yan Fie Cao, for a premises licence in respect of Gornal Dynasty, 105 Kent Street, Upper Gornal, Dudley.

Mr and Mrs Cao were in attendance at the meeting.

Following introductions, the Assistant Director of Law and Property (Legal and Democratic Services) outlined the procedure to be followed. He advised that although no objectors were present at the meeting, consideration would be given to the written objection received.

Mrs Elliott, Licensing Officer, presented the report on behalf of the Council, and confirmed that a written representation had been received from a local resident. Copies of the representation made were attached to the report as Appendix 2.

Mrs Cao pointed out that the objection referred erroneously to the sale of alcoholic drink, whereas this was not the subject of the application. The Assistant Director of Law and Property (Legal and Democratic Services) confirmed that any reference to the sale of alcohol would be disregarded in the decision making. In relation to the aspects of the objections relating to nuisance from litter, Mrs Cao confirmed that litter bins were situated outside the premises and regarding the aspects of the objections relating to vehicular parking, Mrs Cao referred to the availability of parking for patrons at the premises and emphasised that this was not an issue as the majority of their trade involved home deliveries. Mrs Cao confirmed that although the premises were shown to have a restaurant on the plan attached to the report submitted, this was purely an area for customers who having purchased a takeaway meal wished to eat on the premises.

No questions were asked and, at this juncture, the applicant withdrew from the meeting.

The Sub-Committee, having made their decision, invited the applicant to return and the Chairman then outlined the decision and the reasons for the decision.
