I refer to the recent application for renewal of the above PEL. In accordance with Members request, the premises were visited on 24th January 2005 to check the arrangements regarding the windows and ventilation to the premises. There was no amplified music activity occurring at the time, as the visit was made during normal office hours, by

arrangement with the manager.

There are three bay windows to the bar area, which are currently of single glazed, timber framed construction with a secondary glazed unit fitted to the internal bay edge of the windows. The secondary glazed panels can be opened but the single framed windows are sealed shut by paint. I am advised that new sealed double glazed window units are on order to replace the timber framed bays which are rotting and this work is expected to be completed by the end of January/beginning of February 2005. I am also advised that the secondary glazing units will be retained when the new sealed units are fitted, thus providing effectively a triple glazed window to the exterior. The new double glazed sealed units will of course have keys to enable the windows to be opened, but I am advised by the pub manager that the windows will continue to be kept closed. There are two extract fans at either end of the room, which provide mechanical ventilation to the room.

The Karaoke machine was not available for inspection, as it is the property of the visiting compere who brings it with him at weekends. I was thus unable to confirm whether there is any mechanism on the machine that would cut out at 80 dB, nor was I able to confirm the likely noise level at the windows.

I would confirm that complaints of noise regarding this property were last recorded by this department in August 2001.
