Statement of Consultation

1.0 The Council has produced an overarching Statement of Community Involvement which explains how local communities and stakeholders can be involved in the production of the SPD. This Statement of Consultation has been produced to accompany the Planning Obligations SPD and sets out what consultation has taken place so far (including who has been consulted) and what consultation will take place at the formal public consultation stage.

Front Loaded Consultation
