



Thank you for your letter regarding the proposed expansion of Old Swinford Hospital School. The Governors at Redhill identify a number of concerns relating to this proposal. The main concern is that the school appears to be out of line with the Secondary School Review that is currently progressing in Dudley, and that to propose expansion at a time of falling pupil numbers across the borough is not helpful. In Stourbridge there is already a surplus capacity and should your school expand this will put even greater pressure on other local schools. The extra ten boys each year that are not boarders will significantly damage at least one of the Stourbridge schools and will also compound difficulties in already unbalanced population in the others. Ten extra bright boys mean simply ten less to us in our schools and this affects the balance of groups, particularly at the top end of the ability range.

Old Swinford Hospital School is a successful school and we appreciate why you might wish to expand. However, it is time for the school to be a greater point of a local provision and as such to see collaboration as central to the way forward. It is not professional collaboration to act in a way that will knowingly damage you local partners. We would urge you to reconsider the 'local day boys' expansion to prevent a potential schism in local co-operation and good will.
