## Progress report on the development of the Black Country Cluster of PCTs

## Purpose of Report

- 1. The NHS is facing unprecedented challenges. In responding to these challenges, the 2011/12 Operating Framework described the next stage of the NHS reforms. It sets out the conclusion that it will not be possible to retain effective management capacity in all PCTs until their abolition in 2013. In response the current PCTs in the Black Country are being retained as statutory organisations, but there is a consolidation of management capacity, with a single executive team. There is a single Chief Executive, accountable for quality, finance, performance, QIPP and the development of commissioning functions across the Black Country Cluster.
- 2. This report gives a progress report on the development of the Black Country Cluster of PCTs.

### **Progress**

- 3. The Chief Executive for the Black Country Cluster was appointed on 1 April 2011 and is the accountable officer for the four PCTs, Dudley, Sandwell, Walsall and Wolverhampton.
- 4. The Executive team has now been appointed to and is as follows:
  - Director of Commissioning Development/Managing Director of Sandwell PCT Andy Williams
  - Medical Director/ Managing Director of NHS Dudley Steve Cartwright
  - Director of Nursing and Quality/ Managing Director of NHS Walsall Salma Ali
  - Director of Finance (James Green, Acting Director of Finance for Sandwell PCT, is to take up the position of Acting Director of Finance for the cluster until an appointment is made in July).
  - Managing Director of Wolverhampton PCT Jon Crockett
  - Assistant Chief Executive Board Secretary\* Kimara Sharpe
  - Assistant Chief Executive Communications\* Richard Haynes
  - Assistant Chief Executive HR/OD\* Mal Madders
