## CONSULTATION ON THE SCHOOLS FORUMS (ENGLAND) REGULATIONS 2009

The Department is today launching a consultation on the new Schools Forums (England) Regulations 2009.

The main purpose of the draft regulations is to give effect to the government's recent legislation and policy developments. As such, one of the proposed changes is to bring academies into membership of the forum. These draft regulations replace the Schools Forums Regulations 2002 as already amended by the Schools Forums (Amendment) Regulations 2004, 2005, and 2008, and have been re-written for clarity.

We would also like to consult on making the representation of early years PVI providers more effective, and on giving local authorities the option of changing the composition of their schools members of Schools Forums to reflect locality working, from 2011. Additional questions seeking views on these subjects have been added to the accompanying notes.
