It has not been possible to gain access into the premises despite numerous telephone attempts being made by myself. I also believe that the premises operates in the evening after normal working hours. However I would like to make the following representation.

There was a complaint reported in February 2008 alleging noise nuisance from music and behavioural nuisance from customers drinking in the front car park. At the time of the incident the complainant reported that the external doors and windows were open during the entertainment.

Therefore for the above reasons above I would ask the committee to consider the following

## conditions:

- During programmed entertainments, ensure the external doors are kept in the closed position except for access and egress.
- During programmed entertainments, ensure the windows are kept in the closed position.
- Notices should be erected on exit doors asking customers to leave quietly.
