Report of the Director of Law and Property And the Director of Finance

Revision of Licence Fees

Purpose of Report

1. To consider the revision of fees for private hire and hackney carriage licences administered by the Committee.

Background

- 2. The fees for private hire and hackney carriage licences administered by the Committee were last revised with effect from April 2006.
- 3. Fees received in respect of private hire and hackney carriage licences are not refunded if the application is withdrawn or refused.
- 4. In considering the revision of licence fees, the Committee may wish to compare the fees charged by the Council with those of neighbouring Councils. A table showing these comparisons is attached as Appendix 1.
- 5. All vehicles are required to pass a mechanical test at the Council's Lister Road Depot before they are licensed as private hire vehicles or hackney carriages. The fees for these tests, are collected by the Licensing Section, on behalf of the Directorate of the Urban Environment.
- 6. The Senior Policy and Communications Officer, Directorate of the Urban Environment, has requested the following increased fees to reflect increased service costs, as shown overleaf, should be considered by the Committee:-

- 8. The Council is only permitted to set licensing fees up to the amount that can be ascertained as being the cost of administering the licensing function. This includes enforcement, the administrative and ancillary costs of issuing the licence and the ancillary costs relating to members meeting to determine certain licensing applications.
- 9. The cost of licence administration stated in paragraph 14 19 of this report, includes the enforcement and administrative costs of processing the licences but does not include any costs relating to Members.
- 10. The changes in the vehicle testing policy, which were implemented in July 2004, had cost implications. The costs of the awareness pack, including translation and the Enforcement Officers visiting Taxi/Private Hire Bases to assist in the understanding of the pack were absorbed by the Licensing Department. However, from July 2004, vehicles over the age of 8 years old require mechanically testing at Lister Road three times a year, as follows:-

- 11. The third test is a comprehensive mechanical test as are the current first and second tests. Therefore the third test fee is charged at the same rate as the current second test fee.
- 12. The private hire/hackney carriage trade have been consulted with regard to the fees.
- 13. The comments which have been received from the Hackney Carriage Association together with the reply from Mr Peter Lloyd (Policy and Compliance Manager) Transport Services are attached as Appendix 2 to this report.
