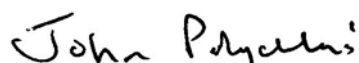

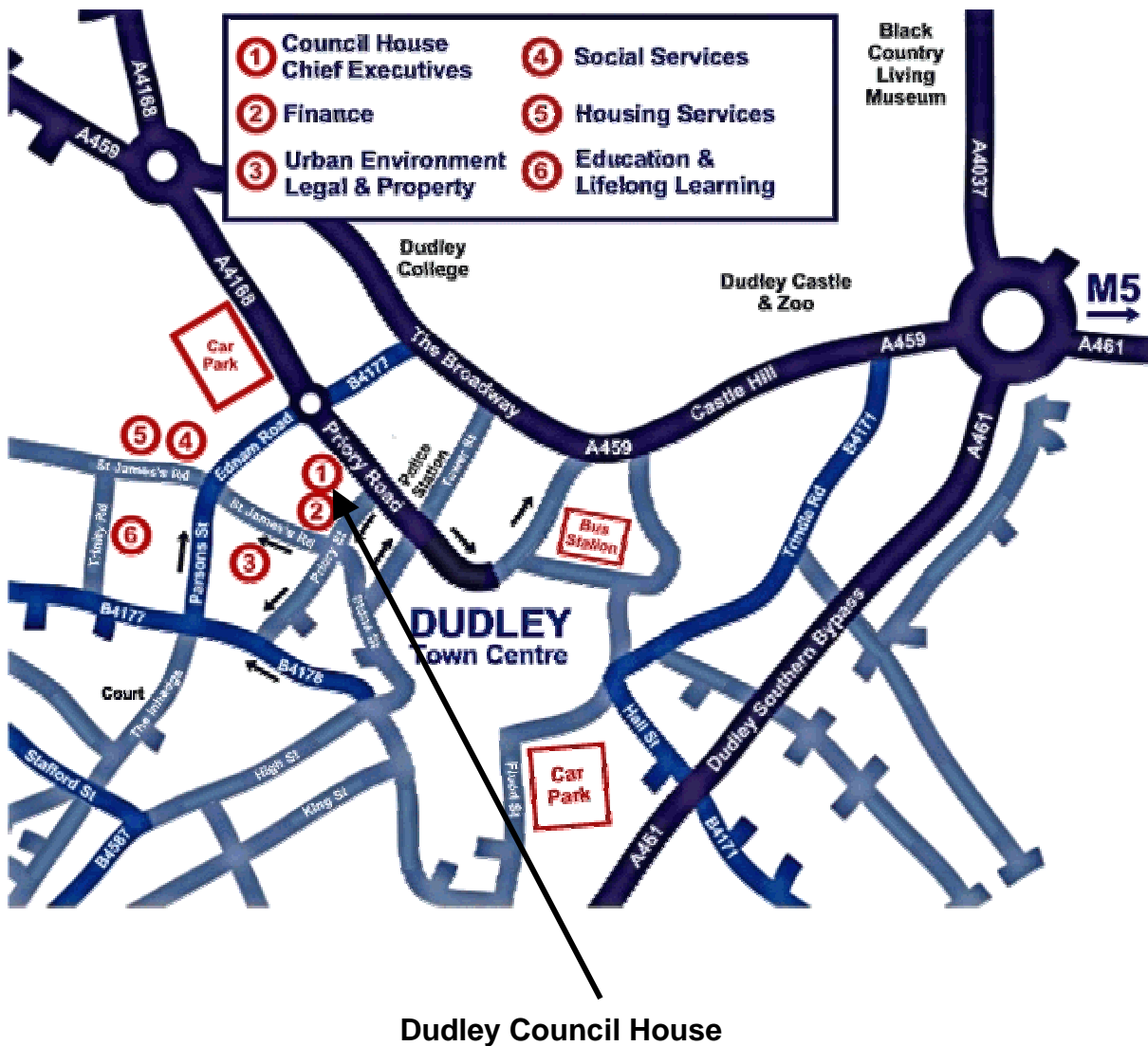

5. CONSTITUTION

To consider and determine the recommendations made at the meeting held on 18th July, 2006, in the terms set out below. Please note that, under the Constitution, amendments to the Constitution require the approval of the Cabinet Member for Children's Services of Dudley MBC and a determination by the Committee to make the amendments will therefore require the approval of the Cabinet Member:

That the Constitution and Terms of Reference of the Committee be amended to include the following:-

- (a) That School Organisation proposals will only be considered by the Committee if they are circulated to Members at least 7 working days in advance of the meeting;

- (b) That proposals will be considered only if they are set out in accordance with the form and documentation in the relevant DfES guidance.
- (c) That proposals will only be considered if the Legal Adviser receives the documentation for the purpose of confirmation of prescribed information at least 5 working days in advance of despatch of the agenda.

N.B. The meeting has been convened as a formal meeting for the purpose of this item and, to approve the amendment, there must be agreement from two thirds of the membership of the Committee, from at least three of the groups.

6. CRADLEY HIGH SCHOOL

To consider, in accordance with the relevant legislative requirements, the proposal of Dudley MBC to discontinue Cradley High School, as set out in the attached published notice dated 24th November, 2006 (group voting will apply).
