# ANNUAL REPORT OF THE SELECT COMMITTEE ON COMMUNITY SAFETY AND COMMUNITY SERVICES

#### Report of the Lead Officer to the Committee

#### 1. Purpose of Report

To submit to Council, the Annual Report of the Select Committee on Community Safety and Community Services for 2006/2007 and to submit a work programme for 2007/2008.

## 2. **Background**

Article 6 of the Council's Constitution requires that Select Committees report annually to the full Council and make recommendations for future work programmes and amended working methods, if appropriate, for the forthcoming year.

The Council's attention is drawn to the attachments at appendices 1, 2 and 3, that indicate the items included in the work programme for review during 2006/2007.

There were no 'call-ins' of decisions relating to the remit of the Committee through the Decision Sheet Process during the year.

### 3. Analysis of the Work Programme for 2006/2007

The Committee continued to consider the wider issues and activities of the Council and its impact on Community Safety within the Borough, with reference to scrutiny and the terms of reference of reviewing aspects of Crime and Disorder and Anti Social Behaviour, and the Council's Corporate Strategy.

The Committee and its Working Groups recognised the importance of strategic partnership working across the Council's services and the partnerships within the area.

The Select Committee operated throughout the year with three Working Groups, the Regulatory Controls Working Group, the Partnership Developments Working Group and the Customer Services and Public Information Working Group. In addition, the Committee were also updated on the impact of the Liquor Licensing legislation and other Licensing initiatives appertaining to community safety, considered the recommendations of the Working Groups, and received feedback from Members and Officers on issues appertaining to community safety and community services and commented generally on statutory policy and financial reports submitted to the Committee by Officers of the Council.

#### 4. **Key Issues Arising**

The major concerns of the Committee continued to reflect the expressions made by local people, namely

- Issues concerning anti social behaviour and the publicising of the names of perpetrators with an Anti Social Behaviour Order (ASBO), and
- Other issues as outlined in the appendix to this report.

## 5. Recommendations made by the Working Groups and Outcomes

The recommendations and outcomes following the consideration of items set out in the Work Programme for 2006/2007 are set out in appendices 1, 2 and 3 attached.

#### 6. Impact of the Select Committee's Recommendations

During 2006/2007 the Committee considered the Director of Law and Property's Equality and Diversity Annual Report and the Equality and Diversity Action Plan for 2007/2008, relevant extracts from the Chief Executive's Quarterly Performance Management Report and updates from the Financial Director on the Council's Capital Strategy and the Proposed Revenue Budget

The Select Committee also supported the publication of Anti Social Behaviour Orders (ASBOS's) and monitored and guided the implementation of the initiative during the 2006/2007 municipal year. The outcome was that the process was implemented in March,2007 subject to an ASBO being issued.

The Committee also received an oral presentation from the two local Chief Superintendents on the delivery of neighbourhood policing within the Dudley area and the Annual Report of the Emergency Planning/Business Continuity Officer for 2005/2006 and a report on Fireworks in Town Centres and Parks, also by the Emergency Planning/Business Continuity Officer. Following consideration of the reports by the Emergency Planning Business Continuity

Officer, the Committee recommended that the multi agency independence of the Safety Advisory Group be recognised by the Committee and expressed their support of the expertise of the various bodies in dealing with public safety at events.

The Committee considered a report of the Chief Executive updating them on the crime figures for the Dudley Borough and a report of the Chief Executive updating them on the progress of the RESPECT Agenda. The Committee resolved that the two Police Superintendents for the Dudley area be invited to a meeting of the Committee in 2007/2008 to discuss the work of the Partners and Communities Together (PACT) meetings and that an item to this effect, be included in the 2007/2008 Work Programme.

The Committee also received reports from the Chairmen of the Working Groups outlining the progress made on the items scheduled for their consideration in 2006/2007 as noted in appendix o this report.

#### 7. Areas and Opportunities for Improvement

Other areas of opportunity, including members' fact finding visits to other local authorities and further training opportunities for Members of the Committee, will continue to be explored.

The Select Committee continued to explore ways of improving the scrutiny function and the processes of the Committee and its Working Groups.
