# **WORK PROGRAMME CONFIRMATION**

# 1.0 **PURPOSE**

1.1 To confirm the provisional work programme for the year.

### 2.0 **BACKGROUND**

- 2.1 This Committee on 23 March 2004 agreed a provisional work programme as follows:
  - 1. Brierley Hill Regeneration Partnership
  - 2. Decline of Dudley's Manufacturing Base
  - 3. Community Development/Community Business Development
  - 4. Neighbourhood Management
  - 5. Unitary Development Plan
  - 6. Town Centres Plans
  - 7. ICT Strategy issues
  - 8. New Technology Centres
  - 9. Visitor Economy Strategy
- 2.2 Following that meeting, it was proposed that a general heading of 'The New Deal Programme' be added to this list which was agreed at the Select Committee.
- 2.3 Since that date, it is clear that the Council's overriding priorities are dealing with the outcomes from the CPA recommendations; the C.A.T.S. programme; the Castle Hill Redevelopment and a major review of Council Property and office accommodation. All but the last issue have traditionally formed part of the remit of the Select Committee. Similarly, it is evident that the Council's property portfolio and staff accommodation can be major forces in the field of economic regeneration and may be worthy of scrutiny.
- 2.4 Set against the view of adding extra items to the provisional work programme is the clear view that came out of the overall Select Committee process last year, which was a concern that for Select Committees to be more effective they would be better concentrating on a limited range of issues and considering them in greater depth.
- 2.5 Whether the provisional list is ten items or is increased to fifteen, consideration must be given to the management of the business throughout the year and in

the context of the standard report in on the 'Appointment of Working Groups' it will be proposed that the working groups are restructured to ensure a better re-alignment to meet the focus of the Select Committee.

3.1 That the Committee confirm the shape of the Work Programme for 2004/2005.
