We, our signatures attached, wish to object to the six items in the variation application, on the following grounds:-

1. The hours of 7am to 2am for music and drinking and from 11pm to 2am for refreshments, are excessive.
 2. Additional hours for pub opening will encourage more social gatherings around the pub entrance adding to the existing nuisance, noise, litter, cigarette stubs, etc. Also the early hours of the morning produce much noise from cars and taxis with horns sounding, etc.
 3. Frequently, windows at the pub are opened so that noise levels, as existing, are increased and become excessive.
 4. This is a residential area and there are many occupied flats in New Street, only yards away.
 5. The pub has no parking space, so adding to the problems associated with longer opening times and increased customer flows.
 6. It is **UNREASONABLE** to add further opening hours to a pub already noted for its noise, loud music and crowded street entrance with cigarette ends, foul language and litter - a 'nuisance' pub.
