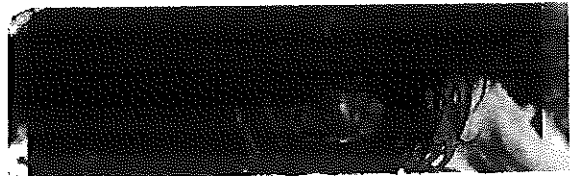

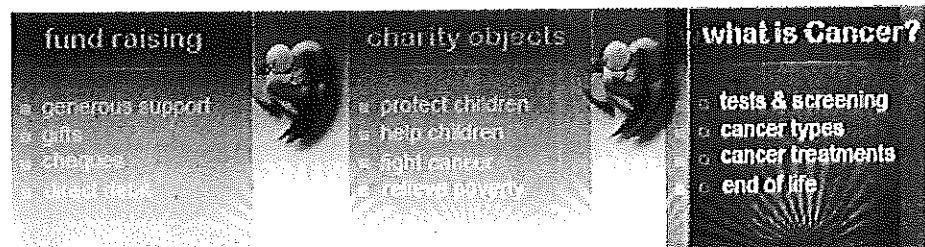
## TCWC - Treating Children with CANCER
