After 24.00 admittance to the premises will only be available to members of the (Bull Hotel Club). In order to gain admittance they will have to produce their membership card. Membership will only be available 48 hours in advance of the proposed first entry to the premises and will only be made available to those who can provide appropriate proof of their identity, a record of which will be kept. Each member will be entitled to sign in one bona fide guest however that guest may only be signed in on one occasion per month. A full record of all members of the Club will be maintained and made available for inspection by the Police or Licensing Authority, a full register of all guests admitted will also be maintained and made available for inspection upon demand by the Police or Licensing Authority. There will be a membership fee to be determined from time to time.
