6. APPLICATION FOR CONSENT TO ENGAGE IN STREET TRADING – HIGH STREET/ COVENTRY STREET, STOURBRIDGE

A report of the Director of Law and Property was submitted on an application received on behalf of Mr Jonathan Skelding for the grant of a consent to engage in street trading in High Street/Coventry Street, Stourbridge.

Mr Skelding was in attendance at the meeting.

Mrs Elliott, Licensing Officer, presented the report on behalf of the Council.

In response to questions asked by a Member of the Sub Committee, Mr Skelding circulated a photograph of the ice cream cart that he intended to use. He also reported that a litter-pick would be carried out once the cart was removed from the site at the end of trading. He also confirmed that he was in communication with the Town Centre Manager with regard to the most suitable site for the cart to be positioned.
