BEST VALUE SERVICE CONTINUOUS IMPROVEMENT PLANS (SCIPs)

1.0 PURPOSE OF REPORT

1.1 To enable the Select Committee to scrutinise the progress of the Service Continuous Improvement Plan (SCIP) of the Waste Management Best Value Review.

2.0 BACKGROUND

- 2.1 In September 2004, the Audit Commission inspected the Council's Waste Management Service, including refuse collection and disposal, recycling and street cleansing. The service was assessed as good, two star with promising prospects for improvement.
- 2.2 However, a number of recommendations were made and Appendix 1 summarises progress against the key improvement actions contained in the Waste Management SCIP.
