# 8 Application for the Grant of a Private Hire Driver's Licence – Mr HI

A report of the Director of Environment was submitted to consider the application for the grant of a Private Hire Driver's Licence to Mr HI.

Mr HI was in attendance at the meeting.

Following the welcome and introductions by the Chair, the Team Manager - Licensing and Waste Enforcement presented the report in detail. Mr HI confirmed that the report was a fair summary, however he provided evidence in the form of an email to prove that no charges had been pursued by West Midlands Police in relation to the allegations referred to in the additional information provided as part of Mr HI's Disclosure and Barring Service report.

Mr HI continued to present his case, explaining the circumstances surrounding the allegations, together with his current living arrangements and health conditions.

Mr HI responded to questions raised by the Committee, and the Team Manager - Licensing and Waste Enforcement confirmed that Mr HI had undertaken a full medical in April 2023, and had been signed fit by a medical practitioner with a further medical required in three years.

At the request of the Chair, Mr HI confirmed that there were no further matters pending that needed to be brought to the Committees attention, following which, the Committee's Solicitor provided a legal summary in relation to the case.

Parties then withdrew from the meeting to enable the Committee to determine the application.

### Resolved

That following careful consideration of the information contained in the report submitted, the evidence provided at the meeting and having regard to the Committee Guidelines and Statutory Standards, in particular Statutory Standard 5.4, the Committee determined that whilst no criminal convictions had been issued, due to the serious nature of the allegations, the Committee were not convinced Mr HI was a fit and proper person, therefore the application to grant a Private Hire Driver's licence to Mr HI be refused.

Mr HI was informed of his right to appeal the decision of the Committee to the Magistrate's Court.

# 9 Application for the Grant of a Private Hire Driver's Licence – Mr NA

A report of the Director of Environment was submitted to consider the application for the grant of a Private Hire Driver's Licence to Mr NA.

Mr NA was in attendance at the meeting, together with his representative Mr Saeed.

Following the welcome and introductions by the Chair, the Team Manager - Licensing and Waste Enforcement presented the report in detail. Mr NA confirmed that the report was a fair summary of the case, and Mr Saeed explained the circumstances surrounding the convictions highlighted on Mr NA's Disclosure and Barring Service report and the reasons as to why these had not been disclosed at the time of submitting his application.

Mr NA responded to questions of the Committee and confirmed that there were no further matters pending that needed to be brought to the Committee's attention.

The Committee's Solicitor provided a legal summary in relation the case, following which all parties withdrew from the meeting to enable the Committee to determine the application.

#### Resolved

That following careful consideration of the information contained in the report submitted, the evidence provided at the meeting and having regard to the Committee Guidelines and Statutory Standards, the Committee were satisfied that Mr NA was a fit and proper person to hold a licence given the explanation provided, therefore, subject to Mr NA undertaking a drugs test, at his own expense, and providing a negative result, a private hire driver's licence, be granted.

# 10 Application for the Grant of a Private Hire Driver's Licence – Mr UDK

A report of the Director of Environment was submitted to consider the application for the grant of a Private Hire Driver's Licence to Mr UDK.

Mr UDK was in attendance at the meeting, together with his representative Mr Saeed.

The Team Manager - Licensing and Waste Enforcement presented the report in detail, following which Mr Saeed on behalf of the applicant presented the circumstances surrounding the failure to disclose on his application that he had previously held a private hire drivers' licence with a neighbouring authority, which had subsequently been revoked.

Following the opportunity to sum up the case and Mr UDK confirming that there were no further matters pending that needed to be brought to the Committee's attention, the Committee's Solicitor provided a legal summary in relation to the case.

All parties then withdrew from the meeting to enable the Committee to determine the application.

### Resolved

That following careful consideration of the information contained in the report submitted, the evidence provided at the meeting and having regard to the Committee Guidelines and Statutory Standards, the Committee were satisfied that Mr UDK was a fit and proper person to hold a licence given the explanation provided, therefore, the private hire driver's licence application for Mr UDK, be granted.

All parties then withdrew from the meeting to allow the Committee opportunity to determine the application.

#### Resolved

That following careful consideration of the information contained in the report submitted, the evidence provided at the meeting and having regard to the Committee Guidelines and Statutory Standards, the Committee were satisfied that Mr LA was a fit and proper person to hold a licence given the explanation provided, therefore, a strong written warning be issued to Mr LA regarding his future conduct.
