**Re: Local Government (Miscellaneous Provisions) Act 1982
Renewal of Licence: Private Shop,

Please find enclosed our application for the renewal of a licence under Schedule 3 of the above Act, in respect of the above premises together with our cheque in the sum of £3420 representing the licence fee currently applicable.

We have previously applied for and have been granted permission to open until 8:00 p.m. Monday to Saturday over the Christmas period. We, therefore, wish to apply for a change to Condition 2(1) of the Conditions attached to the licence. The change requested is to add to Condition 2(1) the words: **"The premises may remain open to 8:00 p.m. Monday to Saturday in the two weeks preceding Christmas each year"**.

As conditions can be further reviewed at the time of annual renewal, the Council would be empowered to consider whether the change should be amended, revoked or extended at that time but, otherwise would become standard. This would save time and expense of making an application each year for a variation of hours over the Christmas period.

With regard to the plans requested in the Council's guidance notes, these were provided with our Application for Grant and nothing has changed. If, however, you wish us to re-submit these, please let us know.


