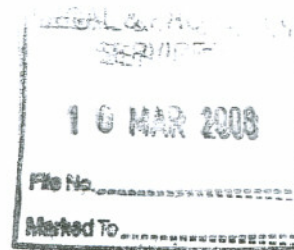

Goals Soccer Centre is a sports centre specialising in the provision of 5-a-side football facilities and operate a number of similar soccer centres throughout the country.

These premises are currently under construction and are due to open in August 2008. They are situate in a largely commercial area.

The centre includes a bar/lounge and multi-use rooms used by those making use of the centre's facilities and the general public but also available for hire for private functions. The multi-use rooms as well as an area in the lounge which can be separated from the bar may also be hired, for example, for children's parties. Football activities usually cease by about 11pm and any late evening activities at the premises are usually pre-booked functions such as, for example, weddings or birthday parties, with invited guests only.

If 5,000 or more people are expected to attend the premises at any one time, please state the number expected to attend.
