# 4 <u>APPLICATION FOR A HOUSE TO HOUSE COLLECTIONS LICENCE – LOCAL COMMUNITY RECYCLING SERVICES.</u>

A report of the Director of Corporate Resources was submitted on an application for the grant of a House to House Collections Licence in respect of Local Community Recycling Services Limited on behalf of the Birmingham Children's Hospital, Cure Leukaemia and the Anthony Nolan Trust.

Mr Fitzgerald, the applicant, was in attendance at the meeting.

Following introductions, the Legal Advisor explained the procedure to be followed.

Mr Jasper, Licensing Enforcement Officer, presented the report on behalf of the Council.

Clarification was sought with regard to the guaranteed amount that would be paid to each charity, the turnover of the Company and the reduction in Directors.

Mr Fitzgerald responded by stating that a minimum of £50 for each tonnage of clothing sold would be paid to each charity regardless of the Company's turnover. Regarding the reduction in Directors this had occurred when Mr Fitzgerald and his brother purchased the Company as employment of the Directors was not cost effective for the Company.

In responding to a question from the Legal Advisor Mr Fitzgerald advised that £75 per tonnage of clothing sold would be paid to the Royal National Lifeboat Institution as certain exemptions applied to that Institution.
